MOTION: Rep. Grover moved to approve the minutes of the February 5, 2009 meeting. The

S.B. 22S2 Notary Public Amendments (Sen. P. Knudson)

MOTION: Rep. Grover moved to adopt 3rd Substitute S.B. 22. The motion passed

unanimously with Rep. Aagard, Rep. Ferry, and Rep. Hendrickson absent for the

vote.

Sen. Knudson explained 3rd Substitute S.B. 22 with the assistance of Spencer Hadley, Lieutenant Governor's Office. A handout was provided that clarified the object of the bill.

# H.B. 269 Solemnizing Marriages Amendment (Rep. D. Aagard)

Rep. Aagard explained the bill to the committee.

MOTION: Rep. Hansen moved to amend the bill as follows:

- 1. Page 2, Lines 28 through 44:
  - 28 (1) Marriages may be solemnized by the following persons only:
    - \* \* \* Some lines not shown \* \* \*
  - 39 (i) the county clerk of any county in the state, if the clerk chooses to solemnize
  - 40 marriages;
  - 41 (j) { the president } members of the Senate;
  - 42 (k) {the speaker} members of the House of Representatives; or
  - 43 (1) a judge or magistrate who holds office in Utah when retired, under rules set by the
  - 44 Supreme Court.

The motion to amend the bill passed with Rep. Mathis voting in opposition to the motion and Rep. Ferry absent for the vote.

Spoke in favor of the bill: Dave Copeland, Davis County

MOTION: Rep. Aagard moved to pass H.B. 269 as amended with a favorable recommendation. The motion passed unanimously with Rep. Bird and Rep. Ferry absent for the vote.

## H.B. 122 Surveyor Amendments (Rep. J. Mathis)

MOTION: Rep. Mathis moved to amend the bill as follows:

- 1. Page 1, Lines 9 through 10:
  - 9 This bill { prohibits, in certain circumstances, the prosecution of a county surveyor or a
  - 10 professional land surveyor for criminal trespass. } provides a defense to criminal trespass that the person is a professional surveyor or county surveyor.
- 2. *Page 1, Lines 14 through 15:* 
  - 14 {prohibits, in certain circumstances, the prosecution of a county surveyor

or a

- 15 <u>professional land surveyor for criminal trespass</u> } <u>provides a defense to criminal</u> trespass that the person is a professional surveyor or county surveyor ; and
- 3. Page 2, Line 48 through Page 3, Line 62:
  - 48 (4) (a) As used in this Subsection (4):
    - (i) "Professional land surveying or the practice of land surveying" is as defined in Section 58-22-102.
      - (ii) "Professional land surveyor" is as defined in Section 58-22-102.
      - (iii) "Surveyor" means a professional land surveyor and a county surveyor.
      - **(b)** It is a defense to prosecution under this section that:
  - 49 {(a)} the property was open to the public when the actor entered or remained; and
  - 50 { (b) } the actor's conduct did not substantially interfere with the owner's use of the
  - 51 property  $\{ -\}$  <u>; or</u>

### (ii)(A) the actor:

(I) is a surveyor or a designee of the surveyor engaged in professional land surveying or the practice of land surveying; or

- (II) in the case of a county surveyor or designee of the county surveyor, is acting under the scope of authority under Title 17, Chapter 23, County Surveyor; and
- (B) the actor's conduct did not substantially interfere with the owner's use of the property.
- $\{(5) (a) \text{ As used in this Subsection } (5):$
- 53 <u>(i) "Professional land surveying or the practice of land surveying" is as defined</u> in
- 54 Section 58-22-102.
- 55 (ii) "Professional land surveyor" is as defined in Section 58-22-102.
- 56 (iii) "Surveyor" means a professional land surveyor and a county surveyor.
- 57 <u>(b) A surveyor does not commit criminal trespass if when the surveyor enters</u>
  and
- 58 <u>remains on the property, the surveyo59</u> <u>(i) (A) is engaged in professional land</u> surveying or the practice of land surveying; or
- 60 (B) in the case of a county surveyor or a designee of the county surveyor, is acting

- 61 under the scope of authority under Title 17, Chapter 23, County Surveyor; and
- 62 (ii) is not acting in violation of this section.

The motion to amend the bill passed unanimously with Rep. Bird and Rep. Ferry absent for the vote.
