MOTION: Rep. Daw moved to approve the minutes of the January 29, 2010 meeting. The motion passed unanimously with Rep. Beck, Rep. Sandstrom, and Rep. Ray absent for the vote.

**H.B. 239 Child Protection Revisions (Rep. W. Harper)**

Rep. Harper explained the bill to the committee.

MOTION: Rep. Daw moved to amend the bill as follows:

*1. Page 7, Lines 196 through 198:*

196 (ii) {+} The {+} ~~{-Unless the time for the provision of reunification~~  
~~services is extended under~~  
197 ~~Subsection 78A-6-314(8), a }~~ permanency hearing shall be held no later than 12 months  
after the  
198 original removal of the minor.

The motion to amend the bill passed unanimously with Rep. Sandstrom absent for the vote.

**H.B. 71S1 Nicotine Product Restrictions (Rep. P. Ray)**

Rep. Ray explained 1st Substitute H.B. 71 bill to the committee. 2nd Substitute H.B. 71 and a proposed amendment were presented for the committee to discuss.

MOTION: Rep. Daw moved to adopt 2nd Substitute H.B. 71. The motion passed unanimously.

**H.B. 232 Medical Language Interpreter Amendments (Rep. R. Chavez-Houck)**

MOTION: Rep. Riesen moved to amend the bill as follows:

1. Page 7, Lines 205 through 207:

205           (10) conviction of a felony or any other crime which is considered by the  
              {~~board~~} division to  
206   represent activity detrimental to the public interest as that interest is reflected in the person  
207   continuing to practice as a certified medical language interpreter.

The motion to amend the bill passed unanimously.
