Rep. Hunsaker called the meeting to order at 8:05 a.m.

MOTION: Rep. Chavez-Houck moved to approve the minutes of Tuesday, February 16, 2010. The motion passed unanimously with Rep. Dunnigan, Rep. Edwards, Rep. Fisher, and Rep. Gibson absent for the vote.

#### **H.B. 401** Residential Facilities for Elderly Persons (*Rep. B. Daw*)

Rep. Daw introduced and explained the bill to the committee, assisted by Mary Street, Orem City Council, and a real estate agent by profession. Questions from the committee were discussed.

MOTION: Rep. Black moved to recommend H.B. 401 favorably. The motion passed unanimously with Rep. Gibson, Rep. Oda and Rep. Poulson absent for the vote.

## H.B. 419 Alcoholic Beverage Control and Signage At State Stores (Rep. K. Powell)

MOTION: Rep. Draxler moved to amend H.B. 419 as follows:

- 2. Page 4, Lines 109 through 110:
  - 109 (c) The text described in Subsection (5)(b) shall be in lettering that is equal to or larger
  - than the size of any text on the same signage that refers to "liquor" or "wine."

Section 2. Coordinates this H.B. 419 with S.B. 167 - Technically merging changes.

If this bill H.B. 419 and S.B. 167, Alcoholic Beverage Control Act Recodification,
both pass, it is the intent of the Legislature that the Office of Legislative Research
and General Counsel in preparing the Utah Code database for publication, because
S.B. 167 takes effect on July 1, 2011, modify Section 32B-2-501 enacted in S.B. 167 to
include, effective July 1, 2011, the following Subsection (5):

- <u>"(5) (a) The commission shall ensure that signage at or near a state store</u> <u>complies with Subsection (5)(b) if the signage is:</u>
  - (i) attached to the exterior of the premises of a state store; or
- (ii) not attached to the premises of a state store, but otherwise alerts or directs a person to the location of a state store.
- (b) Signage described in Subsection (5)(a) shall contain the following words in the size of lettering required by Subsection (5)(c):
  - (i) "state"; or
  - (ii) "State of Utah".
- (c) The text described in Subsection (5)(b) shall be in lettering that is equal to or larger than the size of any text on the same signage that refers to "liquor" or "wine.""

The motion to amend passed favorably with Rep. Gibson, Rep. Oda, and Rep. Poulson absent for the vote.

Rep. Powell explained H.B. 419 and the amendment to the committee. Questions from the committee were addressed.

  - 32 <u>including any form of a water right or</u> { <u>source of a water supply</u> } <u>water shares</u> , if public discussion of the
  - 33 transaction would:
  - 34 (i) disclose the appraisal or estimated value of the property under consideration; or
  - 35 (ii) prevent the public body from completing the transaction on the best possible terms;
  - 36 (e) strategy sessions to discuss the sale of real property, including any form of a water
  - 37 right or { source of a water supply } water shares , if:
