JR7-1-101

Be it resolved by the Legislature of the state of Utah:

Section 1. **JR7-1-101** is enacted to read:

TITLE 7. REDISTRICTING

CHAPTER 1. REDISTRICTING PRINCIPLES

JR7-1-101. Redistricting principles.

(1) When the Legislature exercises its constitutional authority to divide the state into congressional, legislative, and other districts, the Legislature:

- (a) shall draw redistricting plans in an open and transparent process to achieve



28 representative and participatory democracy;

29 (b) shall follow the redistricting principles in Subsection (2); and

30 (c) may follow the redistricting principles in Subsection (3).

31 (2) Redistricting plans shall:

32 (a) comply with the federal and state constitution and the Voting Rights Act of 1965,
33 42 U.S.C. Sec. 1973 et seq.;

34 (b) ensure that state legislative districts and school board districts have substantial
35 equality of population among the various districts, with a deviation not greater than +/- 4%;

36 (c) ensure that congressional districts must be as nearly equal as practicable in the
37 population among the various districts, with a deviation not greater than +/- .5%;

38 (d) ensure that each district is contiguous;

39 (e) ensure that each district is reasonably compact; and

40 (f) be drawn with single member districts.

41 (3) Redistricting plans, to the degree reasonably achievable, strive to:

42 (a) keep municipalities and townships intact;

43 (b) respect existing city and county boundaries;

44 (c) maintain, to the greatest extent possible, communities of common interest; and

45 (d) promote meaningful competition between political parties rather than single party
46 districts which effectively silence the voice of the minority voter, regardless of political party
47 preference.
