29	(1) As used in this section, "entity" means an entity that receives an ongoing line item
30	appropriation in an appropriations act.
31	(2) The Office of Legislative Auditor General shall:
32	(a) dedicate a sufficient portion of its office resources to the regular ongoing audit and
33	review of the budgetary appropriations for an entity at least once every four years;
34	(b) conduct the audit and review described in Subsection (2)(a) according to the
35	process established for the Legislative Audit Subcommittee created in Section 36-12-8;
36	(c) after release of the report by the Legislative Audit Subcommittee, submit the report
37	<u>to:</u>
38	(i) each member of the Utah Senate and the Utah House of Representatives; and

40	(d) in consultation with the legislative fiscal analyst, summarize the findings of each

49	(c) the entity's representatives have acted as diligent and responsible stewards of public

51	(4) The Legislature, in evaluating an entity's request for an increase in its base budget,
52	shall review the report required by this section and any relevant audits and consider the entity's
53	request for an increase in its base budget in light of the agency's prior history of savings and
54	efficiencies as evidenced by the report required by this section.
