General Description:

This concurrent resolution of the Legislature and the Governor encourages state and local governments surrounding the Bear Lake ~~recreation~~ area to work together to ensure responsible development of the area.

Highlighted Provisions:

This resolution:

- ▶ recognizes that the beautiful Bear Lake ~~recreation~~ area is a treasure to be preserved;
- ▶ encourages government entities at both state and local levels that will be impacted by future development at Bear Lake and in the Bear Lake Valley to focus on preserving the beauty, agricultural importance, environmental quality, and ecological balance of this natural resource; ~~and~~

Be it resolved by the Legislature of the state of Utah, the Governor concurring therein:

WHEREAS, Bear Lake is positioned between Idaho and Utah and is one of the focal points of interest belonging to these two great states;

WHEREAS, Bear Lake is considered by many to be the "Caribbean of the West" because of its turquoise blue color;

WHEREAS, Bear Lake has become a recreational destination for people from throughout the West because of the great boating, fishing, hiking, swimming, scouting, and biking opportunities it provides;

WHEREAS, Bear Lake's beautiful scenery, gorgeous sunsets, and changing lake colors provide peace to the soul and natural esthetics that are rare and valuable to all who behold them;

WHEREAS, Bear Lake has been an important source of water for Northern Utah's agricultural interests since the settlement and development of the region and has been and continues to be important to the development and preservation of wetland habitat;

WHEREAS, there is growing recognition that the Bear Lake area will continue to grow and that local development can be beneficial;

WHEREAS, because Bear Lake belongs to all the citizens of Utah and Idaho, the reality of development raises significant concerns for many residents and visitors who hope that the character of Bear Lake and Bear Lake Valley will be preserved, not sacrificed;

WHEREAS, nothing in this resolution is intended to impact the operation of Bear Lake as a reservoir for storage, water delivery, and distribution to water users in the Bear River

Valley:

WHEREAS, several Utah state agencies also have a stake in development along Bear Lake and in the Bear Lake Valley due to its potential impact on this precious resource;

WHEREAS, the state of Idaho also has a vested interest in any development of this area, since portions of the area fall within that state's boundaries; and

WHEREAS, while it may be inevitable that future development will occur along Bear Lake and in the surrounding Bear Lake Valley, it is vital that this development not be allowed to encroach on the beauty, agricultural importance, environmental quality, and ecological balance of this natural resource:

NOW, THEREFORE, BE IT RESOLVED that the Legislature of the state of Utah, the Governor concurring therein, recognize that the beautiful Bear Lake area is a treasure to be preserved.

BE IT FURTHER RESOLVED that the Legislature and the Governor encourage government entities at both state and local levels that will be impacted by future development at Bear Lake and in the Bear Lake Valley to focus on preserving the beauty, agricultural importance, environmental quality, and ecological balance of this natural resource.

BE IT FURTHER RESOLVED that the Legislature and the Governor encourage those governmental entities to preserve the Bear Lake recreation area so that only those light industries and other development that will not interfere with the unique nature of Bear Lake should be allowed in order to preserve the area's beauty and utility for future generations.

BE IT FURTHER RESOLVED that the Legislature and the Governor state that nothing in this resolution is intended to impact the operation of Bear Lake as a reservoir for storage, water delivery, and distribution to water users in the Bear River Valley;

BE IT FURTHER RESOLVED that a copy of this resolution be sent to the Utah Division of State Lands, the Utah Division of Parks and Recreation, the Utah Division of Water Quality, the Utah Division of Water Rights, the Utah Department of Agriculture and Food, Rich County, Cache County, Box Elder County, Bear Lake County, the cities of Woodruff, Randolph, Lake Town, and Garden City, the Utah League of Cities and Towns, the Utah Association of Counties, Bear Lake Watch, the members of Utah's congressional delegation, the members of Idaho's congressional delegation, the cities of St. Charles, Bloomington, Paris, and Montpelier in Idaho, and to Idaho Governor C.L. "Butch" Otter.
