Approval of Minutes

1. **S.B. 312 Economic Development Coordination** (*S. Jenkins*)

Sen. Jenkins explained the bill assisted by Spencer Eccles, Executive Director, Governor's Office of Economic Development both of whom answered questions from the committee.

MOTION: Sen. Jones moved to transmit S.B. 312 with a favorable recommendation.

The motion passed unanimously with Sen. Waddoups absent for the vote.

2. **S.B. 220 Intermountain Weatherization Training Fund** (*S. Jenkins*)

Sen. Jenkins explained the bill and 1st Sub. S.B. 220 was distributed.

MOTION: Sen. Okerlund moved to delete in title and body S.B. 220 and replace it with 1st. Sub. S.B. 220.

The motion passed unanimously.

3. **H.C.R. 16 Resolution Supporting Utah Highway Patrol Use of White Crosses as Roadside Memorial** (*L. Perry*)
