General Description:

This bill provides for an educational program on the use of information technology within the public education and higher education systems.

Highlighted Provisions:

This bill:

- ▶ directs the State Board of Education, Salt Lake Community College, and the ~~{State Board}~~ Utah College of ~~{Regents}~~ Applied Technology to provide for an educational program on the use of information technology; and
- ▶ specifies the components of an educational program on the use of information technology.

Money Appropriated in this Bill:

This bill appropriates for the fiscal year beginning July 1, 2012 and ending June 30, 2013:

- ▶ to the State Board of Education - Utah State Office of Education - Initiative Programs, as an ongoing appropriation:
 - from the Education Fund, \$400,000;~~{and}~~
- ▶ to ~~{the State Board of Regents - Education Excellence}~~ Salt Lake Community College - School of Applied Technology, as an ongoing appropriation:
 - from the General Fund, \$45,000; and
- ▶ to the Utah College of Applied Technology - Administration, as an ongoing appropriation:
 - from the ~~{Education}~~ General Fund, ~~{85}~~ \$40,000.

Other Special Clauses:

Section 1. Section **53A-13-111** is enacted to read:

53A-13-111. Educational program on the use of information technology.

(1) The State Board of Education shall provide for an educational program on the use of information technology, which shall be offered by high schools.

(2) An educational program on the use of information technology shall:

(a) provide instruction on skills and competencies essential for the workplace and requested by employers;

(b) include the following components:

(i) a curriculum;

(ii) online access to the curriculum;
