LONG TITLE

7 **General Description:**

8 This bill changes the membership of the State Water Development Commission.

9 **Highlighted Provisions:**

10 This bill:

- 11 ▶ increases the number of legislators serving on the State Water Development
- 12 Commission;
- 13 ▶ designates non-legislative members of the commission as non-voting members;
- 14 ▶ eliminates the requirement that legislative members on the commission represent
- 15 certain river districts; and
- 16 ▶ makes technical changes.

Be it enacted by the Legislature of the state of Utah:

Section 1. Section **73-27-102** is amended to read:

73-27-102. State Water Development Commission created.

(1) The [~~Joint gubernatorial and Legislative~~] State Water Development Commission is created to determine the state's role in the protection, conservation, and development of the state's water resources.

(2) The commission membership shall include:

(a) [~~four~~] five members of the Senate, [~~of whom:~~] appointed by the president of the Senate, no more than four of whom may be from the same political party;

~~[(i) no more than one shall represent the same river district; and]~~

~~[(ii) no more than two shall be from the same party, except the president of the Senate may appoint up to three senators from the same party if the appointment is necessary to comply with Subsection (2)(a)(i);]~~

(b) [~~six~~] eight members of the House of Representatives, [~~of whom no more than two shall represent the same river district and no more than four shall~~] appointed by the speaker of the House of Representatives, no more than six of whom may be from the same political party;
and

(c) the following non-voting members, appointed by the governor:

~~[(e)]~~ (i) a representative of the Office of the Governor;

~~[(d)]~~ (ii) a representative of the Green River District;

~~[(e)]~~ (iii) a representative of the Upper Colorado River District;

~~[(f)]~~ (iv) a representative of the Lower Colorado River District;

~~[(g)]~~ (v) a representative of the Lower Sevier River District;

~~[(h)]~~ (vi) a representative of the Upper Sevier River District;

~~[(i)]~~ (vii) a representative of the Provo River District;

~~[(j)]~~ (viii) a representative of the Salt Lake District;

~~[(k)]~~ (ix) a representative of the Weber River District;

~~[(l)]~~ (x) a representative of the Bear River District;

~~[(m)]~~ (xi) the executive director of the Department of Natural Resources;

~~[(n)]~~ (xii) the executive director of the Department of Environmental Quality;

- 60 ~~[(p)]~~ (xiv) a member of the Board of Water Resources;
- 61 ~~[(q)]~~ (xv) a representative of an organized environmental group; and
