Be it enacted by the Legislature of the state of Utah:
Section 1. Section <b>26-4-7</b> is amended to read:
26-4-7. Custody by medical examiner.
Upon notification under Section 26-4-8 or investigation by the medical examiner's
office, the medical examiner shall assume custody of a deceased body if it appears that death
