#### **LONG TITLE**

##### **General Description:**

This bill creates the Alzheimer's State Plan Advisory Council within the Division of Aging and Adult Services and describes the duties of the division in relation to Alzheimer's Disease and related dementias.

##### **Highlighted Provisions:**

This bill:

- ▶ defines terms;
- ▶ creates the Alzheimer's State Plan Advisory Council within the Division of Aging and Adult Services in the Department of Human Services;
- ▶ provides that non-legislative members of the advisory council are not entitled to compensation, but may receive per diem and travel expenses;
- ▶ requires the Division of Aging and Adult Services to:

- raise public awareness of Alzheimer's disease and related dementias;
  - partner with law enforcement agencies and the banking sector to curb financial abuse of an individual with Alzheimer's disease or a related dementia;
  - develop an endangered person advisory system; and
  - create a voluntary certification program to train a person who works with an individual who suffers from Alzheimer's disease or a related dementia; and
- ▶ authorizes the Division of Aging and Adult Services to partner with a private or ~~{non-profit}~~non-profit organization to seek private funding for activities authorized under this chapter.

### Money Appropriated in this Bill:

~~{None}~~ This bill appropriates:

- ▶ to the Department of Human Services - Division of Aging and Adult Services:
  - from the Alzheimer's State Plan Restricted Account, \$5,000, subject to intent language that the appropriation shall be used to fund programs and services created by the Alzheimer's Disease and Related Dementias Act.

Section 1. Section **62A-3-501** is enacted to read:

#### **Part 5. Alzheimer's Disease and Related Dementias Act**

#### **62A-3-501. Title.**

This part is known as the "Alzheimer's Disease and Related Dementias Act."

Section 2. Section **62A-3-502** is enacted to read:

### **62A-3-502. Definitions.**

As used in this part:

(1) "Advisory council" means the Alzheimer's State Plan Advisory Council, created in Section 62A-3-402.

(2) "Cognitively impaired person" means a person who, due to age or mental deficiency, suffers from:

(a) long-term or short-term memory loss;

(b) a reduction of deductive or abstract reasoning skills; or

(c) a lack of judgment as it related to safety awareness.

(3) "Department" means the Department of Human Services.

(4) "Division" means the Division of Aging and Adult Services within the department.

(5) "Related dementia" includes:

(a) frontotemporal dementia;

(b) dementia with lewy bodies;

(c) vascular dementia;

(d) Creutzfeldt-Jakob Disease;

(e) Parkinson's disease;

(f) Huntington disease; and

(g) other dementia that is caused by a progressive degeneration of brain cells.

(6) "State plan" means the five-year plan created by the Alzheimer's State Plan Task Force, created in S.B. 48, 2011 General Session.

Section 3. Section **62A-3-503** is enacted to read:

### **62A-3-503. Alzheimer's State Plan Advisory Council -- Creation -- Membership -- Compensation -- Staff -- Private partnership to seek additional funding.**

(1) There is created within the division the Alzheimer's State Advisory Council, consisting of the following members:

(a) each of the following, or a designee of each of the following:

(i) the executive director of the department;

(ii) the executive director of the Department of Health; and

(iii) the director of the division;

(b) a member of the House of Representatives, appointed by the speaker of the House, who shall serve as an ex officio member;

(c) a member of the Senate, appointed by the president of the Senate, who shall serve as an ex officio member; and

(d) the following members appointed by the director of the division:

(i) an individual who has early stage Alzheimer's disease or related dementia;

(ii) an individual who provides care to a family member with Alzheimer's disease or related dementia;

(iii) a licensed physician with experience in the diagnoses, treatment, and research of Alzheimer's disease;

(iv) a representative of the Long-term Care Ombudsman Program within the department;

(v) a representative of the personal home care profession;

(vi) two representatives of the long-term care profession, at least one who represents secure care for individuals with Alzheimer's disease;

(vii) a representative of the insurance profession;

(viii) a representative of the area agencies on aging;

(ix) an individual with expertise in the provision of health services and human services to minorities;

(x) a licensed attorney with experience in elder law;

(xi) two representatives of one or more organizations that provide volunteer services relating to the care and support of a person with Alzheimer's disease; and

(xii) any other individual the director designates as a necessary stakeholder.

(2) Non-legislative members of the advisory council:

(a) shall assist the division in implementing provisions of the Alzheimer's State Plan, as practicable and within existing funding, beginning on May 8, 2012 and ending May 8, 2017; and

(b) may not receive compensation or benefits for the member's service, but may receive per diem and travel expenses in accordance with:

(i) Section 63A-3-106;

(ii) Section 63A-3-107; and

(iii) rules made by the Division of Finance pursuant to Sections 63A-3-106 and 63A-6-107.

(3) A ~~legislator~~member who is ~~fa~~as an ex officio member of the advisory council shall~~;~~

~~— (a) fulfill the duties described in Subsection (2)(a); and~~

~~— (b) receive salaries and expenses in accordance with Section 36-2-2 and Legislative Joint Rules, Title 5, Chapter 3, Expense and Mileage Reimbursement for Authorized Legislative Meetings, Special Sessions, and Veto Override Sessions.~~

(4) The director of the division shall oversee the council and its work.

(5) The division shall provide staff support to the advisory council.

(6) The division may, in consultation with the advisory council, designate a private or nonprofit organization to seek funding in the form of private donations or grants to fund projects authorized under this part. Funds received under this Subsection (6) shall be deposited in the Alzheimer's State Plan Restricted Account.

Section 4. Section **62A-3-504** is enacted to read:

### **62A-3-504. Division duties.**

(1) The division shall:

(a) raise public awareness of Alzheimer's disease and related dementias by:

(i) partnering with the Department of Health to establish a program with health resource guides devoted to Alzheimer's disease and related dementias, as funding allows;

(ii) collaborating with other state agencies to develop and disseminate culturally appropriate print, radio, and television media campaigns for awareness of Alzheimer's disease and related dementias, as funding allows;

(iii) developing electronic links on the department's website to ensure that reliable information about Alzheimer's disease and related dementias is available to citizens;

(iv) providing the following forms on the department's website:

(A) durable power of attorney for healthcare; and

(B) physician orders for life sustaining treatment; and

(v) investigate options for collecting data on the incidence of Alzheimer's disease and related dementias;

(b) partner with law enforcement agencies and the private banking sector to promote

the recognition and curbing of potential financial abuse of an individual with Alzheimer's disease or a related dementia; and

(c) explore options to develop an endangered person advisory system, in conjunction with the AMBER Alert, through a voluntary partnership with law enforcement, broadcasters, media, and community organizations in the event:

(i) a law enforcement agency has confirmed that a cognitively impaired person is missing;

(ii) the law enforcement agency believes the circumstances surrounding the disappearance indicate the person is in danger of serious injury or death; and

(iii) there is enough descriptive information about the disappearance and the person to ensure that an immediate broadcast of the information could aid in the discovery of the person.

(2) The division may seek public and private funding for projects authorized under this part and funds received shall be deposited in the Alzheimer's State Plan Restricted Account.

Section 5. Section **62A-3-505** is enacted to read:

**62A-3-505. Voluntary Alzheimer's disease and related dementias certification program.**

(1) The department shall direct an organization seeking training for its staff or an individual seeking professional training in dementia care or elder care to Foundations of Dementia Care or a similar private program which provides training, testing, and certification on:

(a) the basics of dementia;

(b) improving communication with individuals who suffer from dementia;

(c) understanding behavior of individuals with dementia, including wandering;

(d) reducing the risk of falls;

(e) providing restraint-free care;

(f) making a connection with an individual who suffers from dementia; and

(g) end-of-life care.

(2) The department shall make a list of persons who have successfully completed the certification program described in Subsection (1) available on the department website.

(3) Participation in the certification program described in Subsection (1) is voluntary.

Section 6. Section **62A-3-506** is enacted to read:

**62A-3-506. Alzheimer's State Plan Restricted Account.**

(1) There is created a restricted account within the General Fund known as the "Alzheimer's State Plan Restricted Account."

(2) The account shall be funded by donations and grants from public or private entities.

~~{ (3) Funds in the account are nonlapsing.~~

+ ~~{~~ (~~4~~3) The Legislature shall appropriate funds from the account to fund the operation and support of programs and services provided under this part.

~~{(5) Any funds remaining from grant funds authorized under S.B. 48, 2011 General Session shall be deposited in the}~~ Section 7. Appropriation.
