Be it i	resolved by the Legislature of the state of Utah, the Governor concurring therein:
	WHEREAS, high student performance is fundamentally linked to a public education
syster	n that has a strong system of accountability and transparency consistent with state
standa	ards;
	WHEREAS, the responsibility for the upbringing and education of children lies with

20	parents, supported by local school boards, and the state government;
27	WHEREAS, Utah has an obligation to control Utah's core curriculum, and has the right
28	to modify its education curriculum without being dependent on, or subject to, an entity outside
29	our state;
30	WHEREAS, in 2009 and 2010, the state was offered the chance to compete for
31	education funding through the Race to the Top (RTTT) program created by the United States
32	Department of Education, but no funding was received;
33	WHEREAS, locally elected officials, school leaders, teachers, and parents should be
34	included in the discussion, evaluation, and preparation of the Common Core standards;
35	WHEREAS, some citizens and elected officials want an additional review of, and an
36	opportunity to comment on, the Common Core standards;
37	WHEREAS, no empirical evidence indicates that centralized education standards result
38	in higher student achievement;
39	WHEREAS, the National Assessment of Educational Progress (NAEP) currently allows
40	comparisons of academic achievement to be made across states without the necessity of
41	imposing national standards or curricula;
42	WHEREAS, Utah retains the right and ability of local stakeholders to innovate and
43	continue to make improvement over time;
44	WHEREAS, Utah has recently adopted and funded a computer adaptive testing system
45	aligned with Utah's core standards, which includes implementation of standards and testing,
46	associated professional development, and curriculum restructuring;
47	WHEREAS, the Common Core standards should be reevaluated in light of the newly
48	adopted computer adaptive testing program;
49	WHEREAS, all entities, public and private, that receive taxpayer funds either directly
50	or in the form of a grant, stipend, or any other means are accountable to Utah taxpayers, and the
51	State Board of Education is required annually to post on the Utah Public Finance Website
52	created in Section 63A-3-402, any funds received or spent on development of Utah's core
53	curriculum as a result of the Common Core;
54	WHEREAS, there is no national or multi-state centralized decision making that governs
55	the Utah core standards;
56	WHEREAS, the United States Constitution, which recognizes Utah as a sovereign

57	republic, acknowledges that the federal government has no educational mandate or authority
58	and allows the states to direct their own education systems;
59	WHEREAS, Utah should neither relinquish nor cede control of our education system to
60	a consortium of other states or to the federal government;
61	WHEREAS, Utah was an early leader in objecting to the federal mandates of No Child
62	Left Behind (NCLB) and other federal attempts to interfere with states' rights to control their
63	own public education systems;
64	WHEREAS, Utah is free to fully research and consider all available research, data,
65	experience, principles, and proposals that may lead to continuing improvement and progress in
66	its public education system;
67	WHEREAS, the Governor, the Legislature, and the State Board of Education are
68	engaged in joint efforts to advance education reforms and innovation, which will be enhanced
69	by the required review and reconsideration;
70	WHEREAS, Utah is a governing member of the Smarter Balance Assessment
71	Consortium (SBAC) but has the right to withdraw from this consortium at any time, and the
72	right to complete control of its assessments and student achievement in Utah; and
73	WHEREAS, the State Board of Education has notified the United States Secretary of
74	Education, and the Secretary has confirmed that the federal government acknowledges that
75	Utah is free to maintain the state's independence from all actual, or potential directives or
76	mandates from the federal government in relation to Utah's public education system and the
77	Common Core:
78	NOW, THEREFORE BE IT RESOLVED that the Legislature of the state of Utah, the
79	Governor concurring therein, urges the State Board of Education to reconsider, and update as
80	may be necessary, the board's earlier decision to adopt the Common Core standards and to
81	evaluate the same in light of the newly adopted computer adaptive testing, along with the cost,
82	control, content, and quality of Utah standards and assessments compared to the cost, control,
83	content, and quality of the Common Core standards and SBAC assessments, and the extent to
84	which the state has maintained the state's independence as the sole governing authority for the
85	state's public education system.
