### H.B. 440 Surveyor Licensing Amendments (Rep. V. Peterson)

- 1. *Page 3, Lines 71 through 76:* 
  - 71 [(d) (i)] (ii) have graduated and received an [associates, bachelors, or masters]
  - 72 <u>associate's</u> degree from a land surveying program[, or an equivalent land surveying program,
  - 73 such as a program offered by the Utah College of Applied Technology as approved by the State
  - 74 Board of Regents, established by rule by the division in collaboration with the board], {-and-}
  - 75 [have] successfully completed a program of qualifying experience in land surveying
