(ww) The boundary between House District 33 and House District 39 is changed to follow the West Valley City municipal boundary from the intersection of the West Valley City municipal boundary with 4000 West, west to the point where 4685 West in West Valley City, projected south, intersects with the West Valley City municipal boundary.

(xx) The boundary between House District 30 and House District 39 is changed

to follow the West Valley City municipal boundary from the point where 4685 West in West Valley City, projected south, intersects with the West Valley City municipal boundary, west to the intersection of the municipal boundary with 4725 West.

(yy) The boundary between House District 30 and House District 38 is changed to follow the West Valley City municipal boundary from the intersection of the municipal boundary with 4725 West west to the intersection of the municipal boundary with 4800 West.
