**H.B. 109      Use of Controlled Substances in Research** *(Rep. D. Sanpei)*

1. *Page 8, Line 215:*

215            (i) the person ~~{to whom}~~ who writes the prescription is ~~{issued is}~~  
licensed under Subsection (2); and

2. *Page 10, Lines 305 through 306:*

305    research may produce, possess, ~~{or}~~ administer, ~~{but may not}~~ prescribe or  
or dispense ~~{,}~~ a controlled  
306    substance for research purposes as licensed under Subsection (2) but may not  
otherwise prescribe or dispense a controlled substance listed in Section 58-37-4.2.
