S.B. 103 Personal Injury Protection Arbitration (Sen. C. Bramble)

Senate Bramble introduced and explained the bill.

 - 1. Page 2, Lines 38 through 41:
 - 38 (1) Any dispute regarding the recovery of medical expense benefits or other benefits
 - 39 provided under personal injury protection coverage pursuant to Section 31A-22-307 arising out
 - 40 of the operation, ownership, maintenance, or use of an automobile may be submitted to
 - 41 <u>arbitration</u> {<u>on the initiative of any party</u>} <u>if all parties</u> to the <u>dispute</u> <u>agree</u> .

The motion passed unanimously with Sen. McAdams, Sen. Urquhart, Pres. Waddoups and Sen. Weiler absent for the vote.

 - 13 ► reduces the age from 16 to {-14-} <u>12</u> for children who wish to express their opinion during
 - 14 a child custody proceeding regarding which parent they would prefer to reside with.
 - 2. Page 2, Lines 43 through 47:
 - 43 (d) The court may inquire of the children and take into consideration the children's
 - 44 desires regarding future custody or parent-time schedules, but the expressed desires are not
 - 45 controlling and the court may determine the children's custody or parent-time otherwise. The
 - 46 desires of a child [16] {14} <u>12</u> years of age or older shall be given added weight, but is not the single
 - 47 controlling factor.
