This bill repeals provisions related to the authority or duties of the state auditor.

This bill:

- ▶ repeals the town fiscal committee and provisions requiring the committee to assist, advise, and make recommendations to the state auditor;
- ▶ repeals the Citizens and County Officials Advisory Committee appointed by the state auditor and provisions requiring the committee to assist, advise, and make recommendations to the state auditor;
- ▶ repeals provisions requiring the state auditor to analyze and evaluate certain county budgets; and
- ▶ repeals provisions requiring that the Public Service Commission ~~{collect money and~~

*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section 54-1-12 is amended to read:

54-1-12. Deposit of funds.

All money collected by the commission under any provision of this title shall be deposited without deduction in the state treasury on or before the 15th day of each month next succeeding the month in which the same was received, accompanied by a statement showing the date received [ ~~from whom received, on what account the same was received and the amount thereof. A duplicate statement shall be delivered by the commission to the state auditor and the state treasurer shall give his receipt for the money received and deliver a duplicate thereof to the state auditor~~ ].
