Regular primary elections. (1) (a) The fourth Tuesday of June of each even-numbered year is designated as regular 33 34 primary election day. 35 (b) Each registered political party that chooses to use the primary election process to 36 nominate some or all of its candidates shall comply with the requirements of this section. 37 (2) (a) As a condition for using the state's election system, each registered political 38 party that wishes to participate in the primary election shall: 39 (i) declare their intent to participate in the primary election; (ii) identify one or more registered political parties whose members may vote for the 40 41 registered political party's candidates and whether or not persons identified as unaffiliated with 42 a political party may vote for the registered political party's candidates; and 43 (iii) certify that information to the lieutenant governor no later than 5 p.m. on March 1 44 of each even-numbered year. 45 (b) As a condition for using the state's election system, each registered political party 46 that wishes to participate in the primary election shall: 47 (i) certify the name and office of all of the registered political party's candidates to the lieutenant governor no later than 5 p.m. on the first Monday after the third Saturday in April of 48 49 each even-numbered year; and 50 (ii) certify the name and office of each of its county candidates to the county clerks by 51 5 p.m. on the first Monday after the third Saturday in April of each even-numbered year. 52 (c) By 5 p.m. on the first Wednesday after the third Saturday in April of each 53 even-numbered year, the lieutenant governor shall send the county clerks a certified list of the 54 names of all statewide candidates, multicounty candidates, or single county candidates that 55 shall be printed on the primary ballot and the order the candidates are to appear on the ballot in 56 accordance with Section 20A-6-305. 57 (d) Except for presidential candidates, if a registered political party does not wish to 58 participate in the primary election, it shall submit the names of its county candidates to the

The polling place for voting precinct _____ is ____. The polls will open at 7 83 84 a.m. and continue open until 8 p.m. of the same day. Attest: county clerk." 85 (5) (a) [Candidates,] (i) Except as provided by Subsection (5)(b), a candidate, other than presidential candidates, receiving the highest number of votes cast for each office at the 86 87 regular primary election are nominated by their party or nonpartisan group for that office. 88 (ii) Except as provided by Subsection (5)(b), the two candidates for a nonpartisan office who receive the highest number of votes are nominated to be candidates in the regular 89

91 (b) If two or more candidates, other than presidential candidates, are to be elected to
92 the office at the regular general election[;]:

93 (i) those party candidates equal in number to positions to be filled who receive the
94 highest number of votes at the regular primary election are the nominees of their party for those
95 positions[-]: and

96 (ii) the candidates for nonpartisan office, double in number to positions to be filled,
 97 who receive the highest number of votes at the regular primary election advance to the regular
 98 general election.

(6) (a) When a tie vote occurs in any primary election for any national, state, or other
office that represents more than one county, the governor, lieutenant governor, and attorney
general shall, at a public meeting called by the governor and in the presence of the candidates
involved, select the nominee by lot cast in whatever manner the governor determines.

(b) When a tie vote occurs in any primary election for any county office, the district
court judges of the district in which the county is located shall, at a public meeting called by
the judges and in the presence of the candidates involved, select the nominee by lot cast in
whatever manner the judges determine.

107 (7) The expense of providing all ballots, blanks, or other supplies to be used at any
108 primary election provided for by this section, and all expenses necessarily incurred in the
109 preparation for or the conduct of that primary election shall be paid out of the treasury of the
110 county or state, in the same manner as for the regular general elections.

[(b) By May 1 of the year in which a State Board of Education member's term expires,
the lieutenant governor shall submit the name of each person who has filed a declaration of
candidacy for the State Board of Education to the nominating and recruiting committee for the
State Board of Education.]
