Be it enacted by the Legislature of the state of Utah:

Section 1. {Local } Government Communication Task Force -- Creation --

Membership -- Interim Rules Followed -- Compensation -- Staff.

- (1) There is created the {Local} Government Communications Task Force consisting of the following {19}17 members:
 - (a) two members of the Senate appointed by the president of the Senate;
- (b) {two} three members of the House of Representatives appointed by the speaker of the House of Representatives;
 - (c) {four members appointed} the Layton City Police Chief;
 - (d) the Summit County Sheriff;
 - (e) the Salt Lake County Sheriff or designee;
 - (f) the Salt Lake City Police Chief;
 - (g) a police chief from a class 4 through class 6 county, designated by the Utah

{Association of Counties with one designee each representing:

- (i) the county sheriffs;
- (ii) the county fire departments;
- (iii) county public works operations; and
- (iv) county animal control agencies;
- (d) four members appointed by the Utah League of Cities and Towns with one

designee each representing:

- (i) municipal police chiefs;
- (ii) municipal fire chiefs;
- (iii) municipal public works departments; and
- (iv) municipal animal control agencies;
- (e) one member representing the University of Utah;
- (f) one member representing the Utah Transit Authority;

- (g) one member appointed by the State Office of Education, selected from local school districts that employ public safety officers for their schools;
 - (h) one member from the Unified Police Department of Greater Salt Lake;
 - (i) one member from Police Chiefs Association;
 - (h) the Unified Fire Authority Chief;
 - (i) the Ogden City Fire Chief;
 - (j) the Commissioner of Public Safety, or designee;
 - (k) the Director of the Utah Department of Greater Salt Lake;
 - (j) one member appointed by Salt Lake City; and
- (k) one member appointed by board of directors of the Salt Lake Valley Metro Fire Agency}Corrections, or designee;
- (1) the Chairperson of the Utah Communication Agency Networks Executive Committee;
 - (m) the State of Utah Chief Information Officer; and
 - (n) the Utah Communication Agency Networks Director.
- (2) (a) The president of the Senate shall designate one of the members of the Senate appointed pursuant to Subsection (1)(a) as a cochair of the task force.
- (b) The speaker of the House of Representatives shall designate one of the members from the House of Representatives appointed pursuant to Subsection (1)(b) to serve as a cochair of the task force.
- (3) A majority of the members of the task force constitute a quorum. The action of a majority of a quorum constitutes the action of the task force.
- (4) (a) Salaries and expenses of the members of the task force who are legislators shall be paid in accordance with Section 36-2-2 and Legislative Joint Rules, Title 5, Chapter 3, Expense and Mileage Reimbursement for Authorized Legislative Meetings, Special Sessions, and Veto Override Sessions.
- (b) A member of the task force who is not a legislator may not receive compensation for the member's work associated with the task force, but may receive per diem and reimbursement for travel expenses incurred as a member of the task force at the rates established by the Division of Finance under Sections 63A-3-107 ::
 - (5) The Office of Legislative Research and General Counsel shall provide staff support

to the task force

Section 2. **Duties -- Meetings -- Reports.**

- (1) The task force shall review and make recommendations on {local government} communications systems and infrastructure needed for effective and integrated operation of local government communications and dispatch for law enforcement, fire and emergency rescue services, public works services, and animal control operations}statewide public safety, transportation, public works, and other governmental radio communication systems regarding:
 - (a) current capacity and technologies;
 - (b) projected needs or upgrades;
 - (c) opportunities to increase operational efficiencies and effectiveness; and
 - (d) sustainable funding alternatives.
- (2) The task force shall present a final report, including any proposed legislation, to the **Legislative Management** Executive Appropriations** Committee before December 31, **2013**2014.

Section 3. Appropriation.

Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, for the fiscal year beginning July 1, 2013, and ending June 30, 2014, the following sums of money are appropriated from resources not otherwise appropriated, or reduced from amounts previously appropriated, out of the funds or accounts indicated. These sums of money are in addition to any amounts previously appropriated for fiscal year 2014.
