8   **LONG TITLE**

9   **General Description:**

10           This bill amends the Legislative Oversight and Sunset Act related to Title 58,  
11   Occupations and Professions.

12   **Highlighted Provisions:**

13           This bill:

14           ▶ establishes a uniform sunset date for Title 58, Chapter 13, Health Care Providers  
15   Immunity From Liability Act; and

16           ▶ removes the separate sunset date for Section 58-13-2.5 within Title 58, Chapter 13,  
17   Health Care Providers Immunity From Liability Act.
