12                   This bill amends the Legislative Oversight and Sunset Act related to Title 58,  
13 Occupations and Professions.

14                   **Highlighted Provisions:**

15                   This bill:

16                   ▶ establishes a uniform sunset date for Title 58, Chapter 13, Health Care Providers  
17 Immunity From Liability Act; and

18                   ▶ removes the separate sunset date for Section 58-13-2.5 within Title 58, Chapter 13,  
19 Health Care Providers Immunity From Liability Act.
