LONG TITLE

General Description:

This bill amends Title 63J, Chapter 8, State of Utah Resource Management Plan for Federal Lands, by creating the Green River Energy Zone.

Highlighted Provisions:

This bill:

- ▶ defines the term "Green River Energy Zone";
- ▶ adopts an energy exploration, access, and development policy for the Green River Energy Zone;
- ▶ promotes local, state, and federal collaboration to develop energy and mineral resources in the Green River Energy Zone; and
- ▶ makes technical changes.

Other Special Clauses:

This bill provides an immediate effective date.

This bill coordinates with H.B. 382, Escalante Region Grazing Zone, by providing technical and merging amendments.

426 Section 3. Section **63J-8-105.7** is enacted to read:

427 **63J-8-105.7. Green River Energy Zone established -- Findings -- Management and**
428 **land use priorities.**

429 (1) There is established the Green River Energy Zone in Carbon and Emery Counties
430 for the purpose of maximizing efficient and responsible development of energy and mineral
431 resources.

432 (2) The land area and boundaries of the Green River Energy Zone are described in
433 63J-8-102(8) and illustrated on the maps described in Section 63J-8-105.

434 (3) The state finds that:

435 (a) the lands comprising the Green River Energy Zone contain abundant world class
436 deposits of energy and mineral resources, including oil, natural gas, oil shale, oil sands,
437 gilsonite, coal, phosphate, gold, uranium, and copper, as well as areas with high wind and solar
438 energy potential;

439 (b) for lands within the Carbon County portion of the Green River Energy Zone, the
440 highest management priority is the responsible management, development, and extraction of
441 existing energy and mineral resources in order to provide long-term domestic energy and
442 supplies for Utah and the United States; and

443 (c) for lands within the Emery County portion of the Green River Energy Zone:

444 (i) the responsible management and development of existing energy and mineral
445 resources in order to provide long-term domestic energy and supplies for Utah and the United
446 States is a high management priority; and

447 (ii) the management priority described in Subsection (3)(c)(i) should be balanced with
448 the following high management priorities:

449 (A) watershed health;

450 (B) water storage and water delivery systems;

451 (C) Emery County Heritage Sites;

452 (D) facilities and resources associated with the domestic livestock industry;

453 (E) wildlife and wildlife habitat; and

454 (F) recreation opportunities.

455 (4) The state supports:

456 (a) efficient and responsible full development of all existing energy and mineral
457 resources located within the Green River Energy Zone, including oil, oil shale, natural gas, oil
458 sands, gilsonite, coal, phosphate, gold, uranium, copper, solar, and wind resources; and

459 (b) a cooperative management approach by federal agencies, the state of Utah, and

460 local governments to achieve broadly supported management plans for the full development of
461 all energy and mineral resources within the Green River Energy Zone.

462 (5) The state requests that the federal agencies that administer lands within the Green
463 River Energy Zone:

464 (a) fully cooperate and coordinate with the state of Utah and with Carbon and Emery
465 Counties to develop, amend, and implement land and resource management plans and to
466 implement management decisions that are consistent with the purposes, goals, and policies
467 described in this section to the maximum extent allowed under federal law;

468 (b) expedite the processing, granting, and streamlining of mineral and energy leases
469 and applications to drill, extract, and otherwise develop all existing energy and mineral
470 resources located within the Green River Energy Zone, including oil, natural gas, oil shale, oil
471 sands, gilsonite, coal, phosphate, gold, uranium, copper, solar, and wind resources;

472 (c) allow continued maintenance and increased development of roads, power lines,
473 pipeline infrastructure, and other utilities necessary to achieve the goals, purposes, and policies
474 described in this section;

475 (d) refrain from any planning decisions and management actions that will undermine,
476 restrict, or diminish the goals, purposes, and policies for the Green River Energy Zone as stated
477 in this section; and

478 (e) refrain from implementing a policy that is contrary to the goals and purposes within
479 this section.

480 (6) The state calls upon Congress to establish an intergovernmental standing
481 commission, with membership consisting of representatives from the United States
482 government, the state of Utah, and local governments to guide and control planning and
483 management actions in the Green River Energy Zone in order to achieve and maintain the
484 goals, purposes, and policies described in this section.

485 (7) Notwithstanding the provisions of this section, the state's grazing and livestock
486 policies and plans on land within the Green River Energy Zone shall continue to be governed
487 by Sections 63J-4-401 and 63J-8-104.

488 **Section 4. Effective date.**

489 If approved by two-thirds of all the members elected to each house, this bill takes effect
490 upon approval by the governor, or the day following the constitutional time limit of Utah

491 Constitution Article VII, Section 8, without the governor's signature, or in the case of a veto,
492 the date of veto override.

493 Section 5. **Coordinating S.B. 277 with H.B. 382 -- Technical and merging**
494 **amendments.**

495 If this S.B. 277 and H.B. 382, Escalante Region Grazing Zone, both pass and become
496 law, the Legislature intends that the Office of Legislative Research and General Counsel shall
497 prepare the Utah Code database for publication as follows:

498 (1) change all cross references in Section 63J-8-105 to reflect the renumbering that
499 resulted from merging Section 63J-8-102; and

500 (2) change the cross reference in Subsection 63J-8-105.7(2) from "63J-8-102(8)" to
501 "63J-8-102(9)."
