H.B. 40 Beer Excise Tax Revenue Amendments (Rep. J. Draxler)

MOTION: Rep. Bird moved to amend HB 40 as follows:

1. Page 4, Lines 114 through 118:

114 (ii) (A) Except for the portion distributed under Subsection [32B-2-404\(1\)\(b\)\(iv\)](#) and
115 except as provided in Subsection (2)(a)(ii)(B), a municipality or county shall expend
~~{not less~~
116 than} on prevention from local or state revenue of the municipality or county an
amount that equals or exceeds 10% of the portion distributed under this part to the
municipality or county ~~{on prevention}~~ .
117 (B) Subsection (2)(a)(ii)(A) does not apply to a municipality that in the prior fiscal
year
118 received a distribution of \$5,000 or less under this part.
