 - 47 with Section 17-16-3 [on or after May 10, 2011], <u>and the consolidated offices are on</u> <u>conflicting election schedules</u>, the county legislative body shall pass an
 - 48 ordinance that sets the election schedule for the consolidated offices in a reasonable manner
 - 49 that staggers the terms of county officers as provided in this Subsection (2).
