*Be it enacted by the Legislature of the state of Utah:*

Section 1. Section **53A-6-110** is amended to read:

**53A-6-110. Administrative/supervisory licensing.**

(1) A local school board or charter school governing board may request, and the [State Board of Education] board may grant, a letter of authorization permitting a person with outstanding professional qualifications to serve in any position that requires a person to hold an administrative/supervisory license or certificate, including principal, assistant principal, associate principal, vice principal, assistant superintendent, administrative assistant, director, specialist, or other district position.

(2) [~~The State Board of Education~~] In addition to the positions described in Subsection (1), the board may grant a letter of authorization permitting a person with outstanding professional qualifications to serve in any position [~~at the State Office of Education~~] that requires a person to hold an administrative/supervisory license or certificate.

(3) ~~{(a) In accordance with Subsections (3)(b), (c), and (d), the}~~ The board shall make rules for an administrative/supervisory license that ~~{allows}~~ allow the board to license ~~{applicants}~~ individuals from a variety of professional backgrounds ~~};~~
