This bill:

- ▶ ~~requires the STEM Action Center to coordinate with Southern Utah University and Dixie State University}~~Initiative to promote science, technology, engineering, and mathematics education ~~{and professional development}~~in southern Utah; and
- ▶ requires Southern Utah University and Dixie State University to collaborate with public schools to promote STEM education and provide professional learning in

Money Appropriated in this Bill:

This bill appropriates in fiscal year 2016:

 - from the Education Fund, \$410,000.
- ▶ to Dixie State University – Education and General as an ongoing appropriation:
