	WHEREAS, the Utah Commission on Criminal and Juvenile Justice's 2007 study
"Rape	e in Utah" found that one in three Utah women will be sexually assaulted in her lifetime, a
rate tl	nat is higher than the national average for sexual assault crimes;
	WHEREAS, the Utah Department of Public Safety reports that in 2012, there were 966
repor	ts of rape or attempted rape, which is one rape every nine hours;
	WHEREAS, research by the Utah Commission on Criminal and Juvenile Justice in

2007 and a United States Senate subcommittee 2010 hearing on crime and drugs indicate that

many victims of sexual assault do not report the crime for fear of not being believed;

28	WHEREAS, national research has shown that false reports of sexual assault are rare
29	and no more common than false reports of other types of crime;
30	WHEREAS, sexual assault is a violent crime and has devastating safety and health
