This bill enacts a provision relating to federal land within the state.

Highlighted Provisions:

This bill:

- ▶ directs the ~~{State Tax Commission to identify specified federal land and to make calculations of property tax and other revenues that would be generated if that land were privately owned; and~~
- ▶ ~~requires the State Tax Commission to report to an appropriations subcommittee of the Legislature and to provide a copy of the report to specified federal officers;}~~ Commission for the Stewardship of Public Lands to commission a study and report on federal land within the state; and
- ▶ provides requirements for the study and report.

(b) study and quantify the amount of annual funding that could be generated for public education system if the parcels identified in Subsection (2)(a) were in the state, on a school district by school district basis, if the ownership of federal land is transferred to the state to be managed under Title 53C, School and Institutional Trust Lands Management Act.

~~_____ (3) (a) During the 2016 General Session of the Legislature and every third annual general session thereafter, the commission shall submit a written report to the Public Education Appropriations Subcommittee of the Legislature.~~

~~_____ (b) The report required for management through a state land management administration, established for the purpose of managing the land under the best and most appropriate use to ensure access to the land for agricultural, tourism, and other appropriate uses while also generating revenue for public education;~~

(c) define the potential uses of federal land after its transfer to the state;

(d) prepare a report on the work performed under Subsections (3)(a) shall communicate the results of the commission's work under Subsection (2);
