Section 1. Law Enforcement Use of Force ~~Task Force -- Creation -- Membership~~

~~(5) The Office of Legislative Research and General Counsel shall provide staff support to the committee.~~

Section 2. Duties -- Interim report.

~~(1) The committee shall review;~~ study and make recommendations on the following issues:

(a) current state laws and rules and local ordinances and practices regarding the use of force by law enforcement officers;

(b) the practices and policies of law enforcement agencies regarding use of force by law enforcement officers;

(c) the practices and policies regarding investigations of law enforcement officer use of force;

(d) the practices and policies regarding the use of body cameras by law enforcement officers;

(e) current training provided to law enforcement officers regarding the use of force and deadly force;

(f) state laws relating to fines and forfeitures and whether money from those sources can be used to fund Peace Officer Standards and Training staffing and curriculum;

(g) psychological evaluations of potential law enforcement officers;

(h) ways to address and improve the public perception of law enforcement agencies;

and

(i) resources to provide support for law enforcement officers and their families to reduce instances of domestic violence and suicide among law enforcement officers.

(2) The ~~task force is authorized to meet no more than eight times during the 2015 interim.~~

~~(3) A final report~~ committee shall create a final report of its studies, including any proposed legislation, on or before October 31, 2015.

(3) The report shall be presented to the Law Enforcement and Criminal Justice Interim Committee before November 30, 2015.

~~Section 3. Appropriation:~~

~~Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures Act, for the fiscal year beginning July 1, 2014, and ending June 30, 2015, the following sums of money are appropriated from resources not otherwise appropriated, or reduced from amounts previously appropriated, out of the funds or accounts indicated. These sums of money are in addition to any amount previously appropriated for fiscal year 2015.~~
