H.B. 175 Alzheimer State Plan Amendments (*Rep. P. Ray*)

1. *Page 2, Lines 47 through 52:*

47 (b) has been licensed in a state, district, or territory of the United States, or in a foreign
48country, where the education, experience, or examination requirements are not substantially
49equal to the requirements of this state, if the applicant:
50 ~~(i) passes an examination approved by the division in consultation with the board;~~ **and**
51 ~~(ii) makes up any deficiencies in the education or experience requirements of this~~
52~~section in accordance with division rule in collaboration with the board.~~

The motion passed unanimously with Rep. Ray absent for the vote.
