S.B. 229 Child Support Guidelines Advisory Committee Extension *(Sen. L. Hillyard)*

Sen. Hillyard explained the bill to the committee.

MOTION: Chair Christensen moved to pass the bill out favorably. The motion passed unanimously with Rep. King and Rep. Wheatley absent for the vote.

MOTION: Rep. Cutler moved to place S.B. 229 on the Consent Calendar. The motion passed unanimously with Rep. King and Rep. Wheatley absent for the vote.

S.B. 183 Judicial Salaries and Compensation *(Sen. L. Hillyard)*

H.B. 143 Prohibition on Tattooing of Minors (Rep. L. Christensen)

MOTION: Rep. Cutler moved to replace H.B. 143 with 2nd Substitute H.B. 143. The motion passed unanimously with Rep. Greene absent for the vote.

MOTION: Rep. Cutler moved to pass the bill out favorably as substituted. The motion passed with Rep. King voting in opposition and Rep. Greene absent for the vote.

MOTION: Rep. Oda moved to adjourn the meeting. The motion passed unanimously with Rep. Greene absent for the vote.
