IMMUNIZATION OF STUDENTS AMENDMENTS

LONG TITLE

General Description:

This bill amends provisions related to immunization requirements for students.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ amends requirements for a student seeking an immunization exemption;
- ▶ requires the Department of Health to:
 - develop an immunization exemption form;
 - develop an education module;
 - make an immunization exemption form available, free of charge, online, at certain LEAs, and at local health departments; and
- make rules;
- ▶ amends requirements for transferring a student's exemption from immunization to a new school;
- ▶ requires a school to maintain a list of students who have not received required immunizations;
- ▶ amends provisions related to a conditional enrollment; and
- ▶ makes technical and conforming changes.

44 Section 1. Section **26-1-17.5** is amended to read:

45 **26-1-17.5. Confidential records.**

46 (1) A record classified as confidential under this title shall remain confidential, and be
47 released according to the provisions of this title, notwithstanding Section **63G-2-310**.

48 (2) In addition to those persons granted access to ~~[records]~~ a private record described in
49 Subsection **63G-2-302(1)(b)**, immunization records may be shared among schools, school
50 districts, and local and state health departments and the state Department of Human Services as
51 necessary to ~~[assure]~~ ensure compliance with ~~[Section 53A-11-301]~~ Title 53A, Chapter 11, Part
52 3, Immunization of Students, and to prevent, investigate, and control the causes of epidemic,
53 infectious, communicable, and other diseases affecting the public health.

54 Section 2. Section **53A-11-300.5** is enacted to read:

55 **53A-11-300.5. Definitions.**

56 As used in this part:

- 57 (1) "Certificate of immunization" means:
 58 (a) a certification stating that a student received each required immunization, including
 59 the date each immunization was administered, issued by:
 60 (i) a licensed health care provider;
 61 (ii) an authorized representative of a local health department; or
 62 (iii) an authorized representative of the department; or
 63 (b) verification from the department, through a central database, that a student has
 64 received each required immunization, including the date each immunization was administered.
 65 (2) "Department" means the Department of Health, created in Section [26-1-4](#).
 66 (3) "Immunization exemption form" means a form, described in Section [53A-11-302.5](#),
 67 that exempts a student from one or more required immunizations.
 68 (4) "Local Education Agency" or "LEA" means:
 69 (a) a school district;
 70 (b) a charter school; or
 71 (c) the Utah Schools for the Deaf and the Blind.
 72 (5) "Required immunizations" means immunizations against communicable diseases
 73 required by department rule described in Section [53A-11-303](#).

 75 (a) center-based child care, as defined in Section [26-39-102](#);
 76 (b) a public school, as defined in Section [26-39-102](#);
 77 (c) residential child care, as defined in Section [26-39-102](#); or
 78 (d) a private school that:
 79 (i) is not primarily funded at public expense; and
 80 (ii) provides education to students in any grade from kindergarten through grade 12.
 81 (7) "Student" means an individual who attends a school.

100 (B) the immunization requirements for military children under Section 53A-1-1001.

139 **53A-11-302.5. Immunization exemption form -- Online education module --**
 140 **Renewal requirement.**

141 (1) The department shall:

142 (a) develop an immunization exemption form that:

143 (i) specifies if an exemption is for a medical, personal, or religious belief;

144 (ii) indicates if the individual who signs the form has completed the online education
 145 module described in Subsection (2);

146 (iii) states requirements for a student who has not received required immunizations, in
 147 the event of an outbreak of a vaccine preventable illness;

148 (iv) includes a statement claiming exemption from one or more required
 149 immunizations, signed by:

- 150 (A) a student's parent or legal guardian;
151 (B) for a student who does not have a parent or legal guardian, the student's sibling of
152 legal age; or
153 (C) for a student 18 years of age or older, the student;
154 (v) includes the name and address of the individual who signs the form;
155 (vi) includes the name of the student claiming exemption from one or more required
156 immunizations; and

166 (ii) recommendations to reduce the likelihood of an unvaccinated individual
167 contracting or transmitting a vaccine preventable illness, including how to respond in an
168 outbreak.
169 (b) In developing the online education module, the department shall consult with
170 individuals interested in vaccination requirements, including individuals from organizations for
171 health care professionals.
172 (3) In order to exempt a student from required immunizations, a student's parent or
173 legal guardian:
174 (a) shall complete and present the immunization exemption form described in
175 Subsection (1) to the student's school; and
176 (b) may complete the online education module described in Subsection (2)(a).
177 (4) In order to remain exempt from required immunizations, an exempt student who
178 attends a new school shall:
179 (a) submit a completed immunization exemption form to the student's new school; or
180 (b) ensure that the student's previous school confirms with the student's new school

181 that the student is exempt from required immunizations.

183 **53A-11-303. Department of Health regulations.**

184 (1) [~~The Department of Health~~] In accordance with Title 63G, Chapter 3, Utah
185 Administrative Rulemaking Act, the department shall [adopt] make rules to establish:

186 (a) which immunizations are required as a condition for attending school; and

187 (b) the manner and frequency of [their] the administration of required immunizations.

188 (2) The rules [~~adopted~~] made under Subsection (1) shall:

189 (a) conform to recognized standard medical practices[-]; and

190 [~~(3) The rules shall~~]

191 (b) require [the reporting of] a school to report statistical information and names of

202 (1) [~~Each~~] A school shall retain an official [certificates] certificate of immunization for

203 [~~every~~] an enrolled student[. The certificate becomes a] that is part of the [individual] student's

204 permanent school record [and follows the student through his or her public or private school

205 career].

206 (2) The [~~Department of Health shall provide official certificate of immunization forms~~

207 to public and private] department shall create an immunization form and distribute the

208 immunization form to schools, [physicians] health care providers, and local health departments.

209 [~~The forms referred to in this subsection shall include a clear statement of the student's rights~~

211 [~~(3) Any immunization record provided by a licensed physician, registered nurse, or~~

215 immunization as an official certificate of immunization [and verified by the school district in

227 **Procedure.**

228 ~~[(1) Conditional enrollment time periods may be modified by the department by legally~~
229 ~~adopted rules.]~~

230 (1) A student who has not received the required immunizations may attend school on a
231 conditional enrollment:

232 (a) if the student has received a dose of each required vaccine, but is not due for the
233 next dose of the vaccine under department rule described in Section [53A-11-303](#); or

234 (b) for up to 21 calendar days after:

235 (i) the first day of school for a student who enrolls in a school before October 1; or

236 (ii) the student enrolls in a school for a student who enrolls on or after October 1.

237 ~~[(2) The requirements for conditional enrollment shall apply to each student unless that~~
238 ~~student is exempted under Section [53A-11-302](#).]~~

239 (2) (a) After the conditional enrollment period, a school shall prohibit further

258 Section 9. **Effective date.**

259 This bill takes effect on July 1, 2017.
