H.B. 411 Utah Medicaid Reform Amendments (*Rep. R. Spendlove*)

MOTION: Rep. Stanard moved to return H.B. 411 to the Rules Committee for interim study. The motion passed unanimously with Rep. Froerer, Rep. Schultz, Rep. Webb, and Rep. Knotwell absent for the vote.

S.B. 238 Safety Net Initiative Amendments (*Sen. C. Bramble*)
