- 72 <u>foreseeable manner</u> { , except that where the discharge of the product was caused by a volitional
- 73 <u>act that constituted a criminal offense, then the act shall be considered the sole proximate</u> <u>cause</u>
- 74 of any resulting death, personal injuries, or property damage ; or
- 75 (vi) an action or proceeding commenced to enforce the provisions of 18 U.S.C.
