LONG TITLE

7 **Committee Note:**

8 The Executive Appropriations Committee recommended this bill.

9 **General Description:**

10 This bill supplements or reduces appropriations previously provided for the use and
11 operation of Higher Education for the fiscal year beginning July 1, 2016 and ending June 30, 2017;
12 and appropriates funds for the support and operation of Higher Education for the fiscal year
13 beginning July 1, 2017 and ending June 30, 2018.

14 **Highlighted Provisions:**

15 This bill:

- 16
- 17 ▶ provides appropriations for the use and support of certain state agencies;
 - 18 ▶ provides appropriations for other purposes as described.

19 **Money Appropriated in this Bill:**

20 This bill appropriates \$1,499,000 in operating and capital budgets for fiscal year 2017, all of
21 which is from the Education Fund.

22 This bill appropriates \$1,744,740,300 in operating and capital budgets for fiscal year 2018,
23 including:

- 24
- 25 ▶ \$315,473,700 from the General Fund;
 - 26 ▶ \$645,479,500 from the Education Fund;
 - 27 ▶ \$783,787,100 from various sources as detailed in this bill.

28 **Other Special Clauses:**

29 Section 1 of this bill takes effect immediately. Section 2 of this bill takes effect on July 1,
30 2017.

558 **Section 3. Effective Date.**

559 If approved by two-thirds of all the members elected to each house, Section 1 of this bill
560 takes effect upon approval by the Governor, or the day following the constitutional time limit of

562 the date of override. Section 2 of this bill takes effect on July 1, 2017.
