LONG TITLE

General Description:

This bill addresses sibling visitation for children in the custody of the Division of Child and Family Services.

Highlighted Provisions:

This bill:

- ▶ defines the term "sibling";
- ▶ requires the division to make reasonable efforts for sibling visitation when siblings are separated due to foster care or adoptive placement;
- ▶ allows the court to order sibling visitation when the visitation is in the best interest of the child; and
- ▶ makes technical changes.

32 Section 1. Section 62A-4a-101 is amended to read:

33 **62A-4a-101. Definitions.**

34 As used in this chapter:

35 (1) "Abuse" [~~is-as~~] means the same as that term is defined in Section 78A-6-105.

36 (2) "Adoption services" means:

37 (a) placing children for adoption;

38 (b) subsidizing adoptions under Section 62A-4a-105;

39 (c) supervising adoption placements until the adoption is finalized by the court;

40 (d) conducting adoption studies;

41 (e) preparing adoption reports upon request of the court; and

42 (f) providing postadoptive placement services, upon request of a family, for the
43 purpose of stabilizing a possible disruptive placement.

44 (3) "Child" means, except as provided in Part 7, Interstate Compact on Placement of
45 Children, a person under 18 years of age.

46 [~~5~~] (4) "Chronic abuse" means repeated or patterned abuse.

 - 93 causes of neglect or abuse; and
 - 94 (ii) strengthen the cohabitant's ability to provide safe and acceptable care; and

125 youth, and family services administered by the division in accordance with federal law.

128 ~~[(30)]~~ (31) "Substance abuse" ~~[is-as]~~ means the same as that term is defined in Section
129 [78A-6-105](#).

130 ~~[(31)]~~ (32) "Substantiated" or "substantiation" means a judicial finding based on a
131 preponderance of the evidence that abuse or neglect occurred. Each allegation made or
132 identified in a given case shall be considered separately in determining whether there should be
133 a finding of substantiated.

135 (a) the placement of a minor in a family home, group care facility, or other placement
136 outside the minor's own home, either at the request of a parent or other responsible relative, or

139 (b) services provided for a minor awaiting placement; and

140 (c) the licensing and supervision of a substitute care facility.

142 available at the completion of an investigation that there is a reasonable basis to conclude that
143 abuse, neglect, or dependency occurred. Each allegation made or identified during the course
144 of the investigation shall be considered separately in determining whether there should be a
145 finding of supported.

146 ~~[(34)]~~ (35) "Temporary custody," with regard to the division, means the custody of a
147 child in the division from the date of the shelter hearing until disposition.

148 ~~[(35)]~~ (36) "Transportation services" means travel assistance given to an individual
149 with escort service, if necessary, to and from community facilities and resources as part of a
150 service plan.

151 ~~[(36)]~~ (37) "Unsubstantiated" means a judicial finding that there is insufficient

152 evidence to conclude that abuse or neglect occurred.

153 ~~[(37)]~~ (38) "Unsupported" means a finding at the completion of an investigation that
154 there is insufficient evidence to conclude that abuse, neglect, or dependency occurred.

155 However, a finding of unsupported means also that the division worker did not conclude that
156 the allegation was without merit.

157 ~~[(38)]~~ (39) "Without merit" means a finding at the completion of an investigation by
158 the division, or a judicial finding, that the alleged abuse, neglect, or dependency did not occur,
159 or that the alleged perpetrator was not responsible for the abuse, neglect, or dependency.

160 Section 2. Section **62A-4a-103** is amended to read:

161 **62A-4a-103. Division -- Creation -- Purpose.**

162 (1) (a) There is created the Division of Child and Family Services within the
163 department, under the administration and general supervision of the executive director.

164 (b) The division is the child, youth, and family services authority of the state and has
165 all functions, powers, duties, rights, and responsibilities created in accordance with this
166 chapter, except those assumed by the department.

167 (2) (a) The primary purpose of the division is to provide child welfare services.

168 (b) The division shall, when possible and appropriate, provide in-home services for the
169 preservation of families in an effort to protect the child from the trauma of separation from
170 ~~[his]~~ the child's family, protect the integrity of the family, and the constitutional rights of
171 parents. In keeping with its ultimate goal and purpose of protecting children, however, when a
172 child's welfare is endangered or reasonable efforts to maintain or reunify a child with ~~[his]~~ the
173 child's family have failed, the division shall act in a timely fashion in accordance with the
174 requirements of this chapter and Title 78A, Chapter 6, Part 3, Abuse, Neglect, and Dependency
175 Proceedings, to provide the child with a stable, permanent environment.

176 (3) The division shall also provide domestic violence services in accordance with
177 federal law.

178 Section 3. Section **62A-4a-205** is amended to read:

179 **62A-4a-205. Child and family plan -- Parent-time and relative visitation.**

180 (1) No more than 45 days after a child enters the temporary custody of the division, the
181 child's child and family plan shall be finalized.

182 (2) (a) The division may use an interdisciplinary team approach in developing each

183 child and family plan.

184 (b) The interdisciplinary team described in Subsection (2)(a) may include
185 representatives from the following fields:

- 186 (i) mental health;
- 187 (ii) education; and
- 188 (iii) if appropriate, law enforcement.

189 (3) (a) The division shall involve all of the following in the development of a child's
190 child and family plan:

- 191 (i) both of the child's natural parents, unless the whereabouts of a parent are unknown;
- 192 (ii) the child;
- 193 (iii) the child's foster parents;
- 194 (iv) if appropriate, the child's stepparent; and
- 195 (v) the child's guardian ad litem, if one has been appointed by the court.

196 (b) In relation to all information considered by the division in developing a child and
197 family plan, additional weight and attention shall be given to the input of the child's natural and
198 foster parents upon their involvement pursuant to Subsections (3)(a)(i) and (iii).

199 (c) (i) The division shall make a substantial effort to develop a child and family plan
200 with which the child's parents agree.

201 (ii) If a parent does not agree with a child and family plan:

202 (A) the division shall strive to resolve the disagreement between the division and the
203 parent; and

204 (B) if the disagreement is not resolved, the division shall inform the court of the
205 disagreement.

206 (4) A copy of the child and family plan shall, immediately upon completion, or as soon
207 as reasonably possible thereafter, be provided to the:

- 208 (a) guardian ad litem;
- 209 (b) child's natural parents; and
- 210 (c) child's foster parents.

211 (5) Each child and family plan shall:

- 212 (a) specifically provide for the safety of the child, in accordance with federal law; and
- 213 (b) clearly define what actions or precautions will, or may be, necessary to provide for

214 the health, safety, protection, and welfare of the child.

215 (6) The child and family plan shall set forth, with specificity, at least the following:

216 (a) the reason the child entered into the custody of the division;

217 (b) documentation of the:

218 (i) reasonable efforts made to prevent placement of the child in the custody of the

219 division; or

220 (ii) emergency situation that existed and that prevented the reasonable efforts described

221 in Subsection (6)(b)(i), from being made;

222 (c) the primary permanency plan for the child and the reason for selection of that plan;

223 (d) the concurrent permanency plan for the child and the reason for the selection of that

224 plan;

225 (e) if the plan is for the child to return to the child's family:

226 (i) specifically what the parents must do in order to enable the child to be returned

227 home;

228 (ii) specifically how the requirements described in Subsection (6)(e)(i) may be

229 accomplished; and

230 (iii) how the requirements described in Subsection (6)(e)(i) will be measured;

231 (f) the specific services needed to reduce the problems that necessitated placing the

232 child in the division's custody;

233 (g) the name of the person who will provide for and be responsible for case

235 (h) subject to Subsection (10), a parent-time schedule between the natural parent and

236 the child;

237 (i) subject to Subsection (7), the health and mental health care to be provided to

238 address any known or diagnosed mental health needs of the child;

239 (j) if residential treatment rather than a foster home is the proposed placement, a

240 requirement for a specialized assessment of the child's health needs including an assessment of

241 mental illness and behavior and conduct disorders; [~~and~~]

242 (k) social summaries that include case history information pertinent to case planning[-];

243 and

244 (l) subject to Subsection (12), a sibling visitation schedule.

245 (7) (a) Subject to Subsection (7)(b), in addition to the information required under
246 Subsection (6)(i), the plan shall include a specialized assessment of the medical and mental
247 health needs of a child, if the child:

- 248 (i) is placed in residential treatment; and
- 249 (ii) has medical or mental health issues that need to be addressed.

250 (b) Notwithstanding Subsection (7)(a), a parent shall retain the right to seek a separate
251 medical or mental health diagnosis of the parent's child from a licensed practitioner of the
252 parent's choice.

253 (8) (a) Each child and family plan shall be specific to each child and the child's family,
254 rather than general.

255 (b) The division shall train its workers to develop child and family plans that comply
256 with:

- 257 (i) federal mandates; and
- 258 (ii) the specific needs of the particular child and the child's family.

259 (c) All child and family plans and expectations shall be individualized and contain
260 specific time frames.

261 (d) Subject to Subsection (8)(h), child and family plans shall address problems that:

- 262 (i) keep a child in placement; and
- 263 (ii) keep a child from achieving permanence in the child's life.

264 (e) Each child and family plan shall be designed to minimize disruption to the normal
265 activities of the child's family, including employment and school.

266 (f) In particular, the time, place, and amount of services, hearings, and other
267 requirements ordered by the court in the child and family plan shall be designed, as much as
268 practicable, to help the child's parents maintain or obtain employment.

269 (g) The child's natural parents, foster parents, and where appropriate, stepparents, shall
270 be kept informed of and supported to participate in important meetings and procedures related
271 to the child's placement.

272 (h) For purposes of Subsection (8)(d), a child and family plan may only include
273 requirements that:

- 274 (i) address findings made by the court; or
- 275 (ii) (A) are requested or consented to by a parent or guardian of the child; and

276 (B) are agreed to by the division and the guardian ad litem.

277 (9) (a) Except as provided in Subsection (9)(b), with regard to a child who is three
278 years of age or younger, if the plan is not to return the child home, the primary permanency
279 plan for that child shall be adoption.

280 (b) Notwithstanding Subsection (9)(a), if the division documents to the court that there
281 is a compelling reason that adoption, reunification, guardianship, and a placement described in
282 Subsection 78A-6-306(6)(e) are not in the child's best interest, the court may order another
283 planned permanent living arrangement in accordance with federal law.

284 (10) (a) Except as provided in Subsection (10)(b), parent-time may only be denied by a
285 court order issued pursuant to Subsections 78A-6-312(3), (6), and (7).

286 (b) Notwithstanding Subsection (10)(a), the person designated by the division or a
287 court to supervise a parent-time session may deny parent-time for that session if the supervising
288 person determines that, based on the parent's condition, it is necessary to deny parent-time in
289 order to:

290 (i) protect the physical safety of the child;

291 (ii) protect the life of the child; or

292 (iii) consistent with Subsection (10)(c), prevent the child from being traumatized by
293 contact with the parent.

294 (c) In determining whether the condition of the parent described in Subsection (10)(b)
295 will traumatize a child, the person supervising the parent-time session shall consider the impact
296 that the parent's condition will have on the child in light of:

297 (i) the child's fear of the parent; and

298 (ii) the nature of the alleged abuse or neglect.

299 (11) The division shall consider visitation with their grandparents for children in state
300 custody if the division determines visitation to be in the best interest of the child and:

301 (a) there are no safety concerns regarding the behavior or criminal background of the
302 grandparents;

303 (b) allowing visitation would not compete with or undermine the reunification plan;

304 (c) there is a substantial relationship between the grandparents and children; and

305 (d) the visitation will not unduly burden the foster parents.

306 (12) The child and family plan shall incorporate all reasonable efforts for sibling

307 visitation when:

- 308 (a) siblings are separated due to foster care or adoptive placement; and
- 309 (b) visitation is in the best interest of the child for whom the plan is developed.

310 Section 4. Section **78A-6-301** is amended to read:

311 **78A-6-301. Definitions.**

312 As used in this part:

313 (1) "Custody" means the custody of a minor in the Division of Child and Family
314 Services as of the date of disposition.

315 (2) "Protective custody" means the shelter of a child by the Division of Child and
316 Family Services from the time the child is removed from home until the earlier of:

- 317 (a) the shelter hearing; or
- 318 (b) the child's return home.

319 (3) "Sibling" means the same as that term is defined in Section [62A-4a-101](#).

320 ~~[(3)]~~ (4) "Temporary custody" means the custody of a child in the Division of Child
321 and Family Services from the date of the shelter hearing until disposition.

322 Section 5. Section **78A-6-312** is amended to read:

323 **78A-6-312. Dispositional hearing -- Reunification services -- Exceptions.**

324 (1) The court may:

- 325 (a) make any of the dispositions described in Section [78A-6-117](#);
- 326 (b) place the minor in the custody or guardianship of any:

- 327 (i) individual; or
- 328 (ii) public or private entity or agency; or

329 (c) order:

- 330 (i) protective supervision;
- 331 (ii) family preservation;
- 332 (iii) subject to Subsections (12)(b), [78A-6-105\(27\)\(d\)](#), and [78A-6-117\(2\)\(n\)](#) and

333 Section [78A-6-301.5](#), medical or mental health treatment; ~~[or]~~

334 (iv) sibling visitation; or

335 ~~[(iv)]~~ (v) other services.

336 (2) Whenever the court orders continued removal at the dispositional hearing, and that
337 the minor remain in the custody of the division, the court shall first:

338 (a) establish a primary permanency plan for the minor; and
339 (b) determine whether, in view of the primary permanency plan, reunification services
340 are appropriate for the minor and the minor's family, pursuant to Subsections [~~(20)~~] (21)
341 through [~~(22)~~] (23).

342 (3) Subject to Subsections (6) and (7), if the court determines that reunification
343 services are appropriate for the minor and the minor's family, the court shall provide for
344 reasonable parent-time with the parent or parents from whose custody the minor was removed,
345 unless parent-time is not in the best interest of the minor.

346 (4) In cases where obvious sexual abuse, sexual exploitation, abandonment, severe
347 abuse, or severe neglect are involved, neither the division nor the court has any duty to make
348 "reasonable efforts" or to, in any other way, attempt to provide reunification services, or to
349 attempt to rehabilitate the offending parent or parents.

350 (5) In all cases, the minor's health, safety, and welfare shall be the court's paramount
351 concern in determining whether reasonable efforts to reunify should be made.

352 (6) For purposes of Subsection (3), parent-time is in the best interests of a minor unless
353 the court makes a finding that it is necessary to deny parent-time in order to:

- 354 (a) protect the physical safety of the minor;
- 355 (b) protect the life of the minor; or
- 356 (c) prevent the minor from being traumatized by contact with the parent due to the
357 minor's fear of the parent in light of the nature of the alleged abuse or neglect.

358 (7) Notwithstanding Subsection (3), a court may not deny parent-time based solely on a
359 parent's failure to:

- 360 (a) prove that the parent has not used legal or illegal substances; or
- 361 (b) comply with an aspect of the child and family plan that is ordered by the court.

362 (8) (a) In addition to the primary permanency plan, the court shall establish a
363 concurrent permanency plan that shall include:

- 364 (i) a representative list of the conditions under which the primary permanency plan will
365 be abandoned in favor of the concurrent permanency plan; and
- 366 (ii) an explanation of the effect of abandoning or modifying the primary permanency
367 plan.

368 (b) In determining the primary permanency plan and concurrent permanency plan, the

369 court shall consider:

370 (i) the preference for kinship placement over nonkinship placement;

371 (ii) the potential for a guardianship placement if the parent-child relationship is legally
372 terminated and no appropriate adoption placement is available; and

373 (iii) the use of an individualized permanency plan, only as a last resort.

374 (9) A permanency hearing shall be conducted in accordance with Subsection
375 78A-6-314(1)(b) within 30 days after the day on which the dispositional hearing ends if
376 something other than reunification is initially established as a minor's primary permanency
377 plan.

378 (10) (a) The court may amend a minor's primary permanency plan before the
379 establishment of a final permanency plan under Section 78A-6-314.

380 (b) The court is not limited to the terms of the concurrent permanency plan in the event
381 that the primary permanency plan is abandoned.

382 (c) If, at any time, the court determines that reunification is no longer a minor's primary
383 permanency plan, the court shall conduct a permanency hearing in accordance with Section
384 78A-6-314 on or before the earlier of:

385 (i) 30 days after the day on which the court makes the determination described in this
386 Subsection (10)(c); or

387 (ii) the day on which the provision of reunification services, described in Section
388 78A-6-314, ends.

389 (11) (a) If the court determines that reunification services are appropriate, it shall order
390 that the division make reasonable efforts to provide services to the minor and the minor's
391 parent for the purpose of facilitating reunification of the family, for a specified period of time.

392 (b) In providing the services described in Subsection (11)(a), the minor's health, safety,
393 and welfare shall be the division's paramount concern, and the court shall so order.

394 (12) (a) The court shall:

395 (i) determine whether the services offered or provided by the division under the child
396 and family plan constitute "reasonable efforts" on the part of the division;

397 (ii) determine and define the responsibilities of the parent under the child and family
398 plan in accordance with Subsection 62A-4a-205(6)(e); and

399 (iii) identify verbally on the record, or in a written document provided to the parties,

400 the responsibilities described in Subsection (12)(a)(ii), for the purpose of assisting in any future
401 determination regarding the provision of reasonable efforts, in accordance with state and
402 federal law.

403 (b) If the parent is in a substance abuse treatment program, other than a certified drug
404 court program:

405 (i) the court may order the parent to submit to supplementary drug or alcohol testing in
406 addition to the testing recommended by the parent's substance abuse program based on a
407 finding of reasonable suspicion that the parent is abusing drugs or alcohol; and

408 (ii) the court may order the parent to provide the results of drug or alcohol testing
409 recommended by the substance abuse program to the court or division.

410 (13) (a) The time period for reunification services may not exceed 12 months from the
411 date that the minor was initially removed from the minor's home, unless the time period is
412 extended under Subsection 78A-6-314(7).

413 (b) Nothing in this section may be construed to entitle any parent to an entire 12
414 months of reunification services.

415 (14) (a) If reunification services are ordered, the court may terminate those services at
416 any time.

417 (b) If, at any time, continuation of reasonable efforts to reunify a minor is determined
418 to be inconsistent with the final permanency plan for the minor established pursuant to Section
419 78A-6-314, then measures shall be taken, in a timely manner, to:

420 (i) place the minor in accordance with the permanency plan; and

421 (ii) complete whatever steps are necessary to finalize the permanent placement of the
422 minor.

423 (15) Any physical custody of the minor by the parent or a relative during the period
424 described in Subsections (11) through (14) does not interrupt the running of the period.

425 (16) (a) If reunification services are ordered, a permanency hearing shall be conducted
426 by the court in accordance with Section 78A-6-314 at the expiration of the time period for
427 reunification services.

428 (b) The permanency hearing shall be held no later than 12 months after the original
429 removal of the minor.

430 (c) If reunification services are not ordered, a permanency hearing shall be conducted

431 within 30 days, in accordance with Section 78A-6-314.

432 (17) With regard to a minor in the custody of the division whose parent or parents are
433 ordered to receive reunification services but who have abandoned that minor for a period of six
434 months from the date that reunification services were ordered:

435 (a) the court shall terminate reunification services; and

436 (b) the division shall petition the court for termination of parental rights.

437 (18) When a court conducts a permanency hearing for a minor under Section
438 78A-6-314, the court shall attempt to keep the minor's sibling group together if keeping the
439 sibling group together is:

440 (a) practicable; and

441 (b) in accordance with the best interest of the minor.

442 (19) When siblings are separated, a court may order sibling visitation according to the
443 court's determination of the best interests of the child for whom the hearing is held.

444 [~~(19)~~] (20) (a) Because of the state's interest in and responsibility to protect and provide
445 permanency for minors who are abused, neglected, or dependent, the Legislature finds that a
446 parent's interest in receiving reunification services is limited.

447 (b) The court may determine that:

448 (i) efforts to reunify a minor with the minor's family are not reasonable or appropriate,
449 based on the individual circumstances; and

450 (ii) reunification services should not be provided.

451 (c) In determining "reasonable efforts" to be made with respect to a minor, and in
452 making "reasonable efforts," the minor's health, safety, and welfare shall be the paramount
453 concern.

454 [~~(20)~~] (21) There is a presumption that reunification services should not be provided to
455 a parent if the court finds, by clear and convincing evidence, that any of the following
456 circumstances exist:

457 (a) the whereabouts of the parents are unknown, based upon a verified affidavit
458 indicating that a reasonably diligent search has failed to locate the parent;

459 (b) subject to Subsection [~~(21)~~] (22)(a), the parent is suffering from a mental illness of
460 such magnitude that it renders the parent incapable of utilizing reunification services;

461 (c) the minor was previously adjudicated as an abused child due to physical abuse,

462 sexual abuse, or sexual exploitation, and following the adjudication the minor:
463 (i) was removed from the custody of the minor's parent;
464 (ii) was subsequently returned to the custody of the parent; and
465 (iii) is being removed due to additional physical abuse, sexual abuse, or sexual
466 exploitation;
467 (d) the parent:
468 (i) caused the death of another minor through abuse or neglect;
469 (ii) committed, aided, abetted, attempted, conspired, or solicited to commit:
470 (A) murder or manslaughter of a child; or
471 (B) child abuse homicide;
472 (iii) committed sexual abuse against the child;
473 (iv) is a registered sex offender or required to register as a sex offender; or
474 (v) (A) intentionally, knowingly, or recklessly causes the death of another parent of the
475 child;
476 (B) is identified by a law enforcement agency as the primary suspect in an investigation
477 for intentionally, knowingly, or recklessly causing the death of another parent of the child; or
478 (C) is being prosecuted for or has been convicted of intentionally, knowingly, or
479 recklessly causing the death of another parent of the child;
480 (e) the minor suffered severe abuse by the parent or by any person known by the
481 parent, if the parent knew or reasonably should have known that the person was abusing the
482 minor;
483 (f) the minor is adjudicated an abused child as a result of severe abuse by the parent,
484 and the court finds that it would not benefit the minor to pursue reunification services with the
485 offending parent;
486 (g) the parent's rights are terminated with regard to any other minor;
487 (h) the minor was removed from the minor's home on at least two previous occasions
488 and reunification services were offered or provided to the family at those times;
489 (i) the parent has abandoned the minor for a period of six months or longer;
490 (j) the parent permitted the child to reside, on a permanent or temporary basis, at a
491 location where the parent knew or should have known that a clandestine laboratory operation
492 was located;

493 (k) except as provided in Subsection [~~(21)~~] (22)(b), with respect to a parent who is the
494 child's birth mother, the child has fetal alcohol syndrome, fetal alcohol spectrum disorder, or
495 was exposed to an illegal or prescription drug that was abused by the child's mother while the
496 child was in utero, if the child was taken into division custody for that reason, unless the
497 mother agrees to enroll in, is currently enrolled in, or has recently and successfully completed a
498 substance abuse treatment program approved by the department; or

499 (l) any other circumstance that the court determines should preclude reunification
500 efforts or services.

501 [~~(21)~~] (22) (a) The finding under Subsection [~~(20)~~] (21)(b) shall be based on competent
502 evidence from at least two medical or mental health professionals, who are not associates,
503 establishing that, even with the provision of services, the parent is not likely to be capable of
504 adequately caring for the minor within 12 months after the day on which the court finding is
505 made.

506 (b) A judge may disregard the provisions of Subsection [~~(20)~~] (21)(k) if the court finds,
507 under the circumstances of the case, that the substance abuse treatment described in Subsection
508 [~~(20)~~] (21)(k) is not warranted.

509 [~~(22)~~] (23) In determining whether reunification services are appropriate, the court
510 shall take into consideration:

511 (a) failure of the parent to respond to previous services or comply with a previous child
512 and family plan;

513 (b) the fact that the minor was abused while the parent was under the influence of
514 drugs or alcohol;

515 (c) any history of violent behavior directed at the child or an immediate family
516 member;

517 (d) whether a parent continues to live with an individual who abused the minor;

518 (e) any patterns of the parent's behavior that have exposed the minor to repeated abuse;

519 (f) testimony by a competent professional that the parent's behavior is unlikely to be
520 successful; and

521 (g) whether the parent has expressed an interest in reunification with the minor.

522 [~~(23)~~] (24) (a) If reunification services are not ordered pursuant to Subsections [~~(19)~~]
523 (20) through [~~(21)~~] (22), and the whereabouts of a parent become known within six months

524 after the day on which the out-of-home placement of the minor is made, the court may order
525 the division to provide reunification services.

526 (b) The time limits described in Subsections (2) through (18) are not tolled by the
527 parent's absence.

528 [~~(24)~~] (25) (a) If a parent is incarcerated or institutionalized, the court shall order
529 reasonable services unless it determines that those services would be detrimental to the minor.

530 (b) In making the determination described in Subsection [~~(24)~~] (25)(a), the court shall
531 consider:

- 532 (i) the age of the minor;
- 533 (ii) the degree of parent-child bonding;
- 534 (iii) the length of the sentence;
- 535 (iv) the nature of the treatment;
- 536 (v) the nature of the crime or illness;
- 537 (vi) the degree of detriment to the minor if services are not offered;
- 538 (vii) for a minor 10 years old or older, the minor's attitude toward the implementation
539 of family reunification services; and
- 540 (viii) any other appropriate factors.

541 (c) Reunification services for an incarcerated parent are subject to the time limitations
542 imposed in Subsections (2) through (18).

543 (d) Reunification services for an institutionalized parent are subject to the time
544 limitations imposed in Subsections (2) through (18), unless the court determines that continued
545 reunification services would be in the minor's best interest.

546 [~~(25)~~] (26) If, pursuant to Subsections [~~(20)~~] (21)(b) through (l), the court does not
547 order reunification services, a permanency hearing shall be conducted within 30 days, in
548 accordance with Section 78A-6-314.
