7	LONG TITLE
8	General Description:
9	This bill requires the Department of Health to create an online education module
10	regarding certain preventable diseases.
11	Highlighted Provisions:
12	This bill:
13	► defines terms;
14	requires the Department of Health to create an online education module regarding
15	certain preventable diseases;
16	amends the grounds for exemptions from required vaccines;
17	 requires the renewal of a student's vaccination exemption under certain conditions;
18	 requires the Department of Health to create a new vaccination exemption form;
19	 allows for the vaccination exemption form to be completed online in conjunction
20	with the education module;
21	 discontinues the practice of allowing local health departments to vaccinate students
22	and recover costs; and
23	makes technical changes.

43	Be it enacted by the Legislature of the state of Utah:
44	Section 1. Section 26-7-9 is enacted to read:
45	26-7-9. Online public health education module.
46	(1) As used in this section:
47	(a) "Health care provider" means the same as that term is defined in Section
48	<u>78B-3-403.</u>
49	(b) "Nonimmune" means that a child or an individual:
50	(i) has not received each vaccine required in Section 53A-11-303 and has not
51	developed a natural immunity through previous illness to a vaccine-preventable disease, as
52	documented by a health care provider;
53	(ii) cannot receive each vaccine required in Section 53A-11-303; or
54	(iii) is otherwise known to not be immune to a vaccine-preventable disease.
55	(c) "Vaccine-preventable disease" means an infectious disease that can be prevented by
56	a vaccination required in Section 53A-11-303.

57	(2) The department shall develop an online education module regarding
58	vaccine-preventable diseases:
59	(a) to assist a parent of a nonimmune child to:
60	(i) recognize the symptoms of vaccine-preventable diseases;
61	(ii) respond in the case of an outbreak of a vaccine-preventable disease;
62	(iii) protect children who contract a vaccine-preventable disease; and
63	(iv) prevent the spread of vaccine-preventable diseases;
64	(b) that contains only the following:
65	(i) information about vaccine-preventable diseases necessary to achieve the goals
66	stated in Subsection (2)(a), including the best practices to prevent the spread of
67	vaccine-preventable diseases;
68	(ii) recommendations to reduce the likelihood of a nonimmune individual contracting
69	or transmitting a vaccine-preventable disease; and
70	(iii) information about additional available resources related to vaccine-preventable
71	diseases and the availability of low-cost vaccines;
72	(c) that includes interactive questions or activities; and
73	(d) that is expected to take an average user 20 minutes or less to complete, based on
74	user testing.
75	(3) In developing the online education module described in Subsection (2), the
76	department shall consult with individuals interested in vaccination or vaccine-preventable
77	diseases, including:
78	(a) representatives from organizations of health care professionals; and
79	(b) parents of nonimmune children.
80	(4) The department shall make the online education module described in Subsection
81	(2) publicly available to parents through:
82	(a) a link on the department's website;
83	(b) county health departments, as that term is defined in Section 26A-1-102;
84	(c) local health departments, as that term is defined in Section 26A-1-102;
85	(d) local education agencies, as that term is defined in Section 53A-1-401; and
86	(e) other public health programs or organizations.
87	(5) The department shall report to the Health and Human Services Interim Committee

00	before November 50, 2017, regarding compliance with this section.
89	Section 2. Section 53A-11-300.5 is enacted to read:
90	53A-11-300.5. Definitions.
91	As used in this part:
92	(1) "Department" means the Department of Health, created in Section 26-1-4.
93	(2) "Health official" means an individual designated by a local health department from
94	within the local health department to consult and counsel parents and licensed health care
95	providers, in accordance with Subsection 53A-11-302.5(2)(a).
96	(3) "Health official designee" means a licensed health care provider designated by a
97	local health department, in accordance with Subsection 53A-11-302.5(2)(b), to consult with
98	parents, licensed health care professionals, and school officials.
99	(4) "Immunization" or "immunize" means a process through which an individual
100	develops an immunity to a disease, through vaccination or natural exposure to the disease.
101	(5) "Immunization record" means a record relating to a student that includes:
102	(a) information regarding each required vaccination that the student has received,
103	including the date each vaccine was administered, verified by:
104	(i) a licensed health care provider;
105	(ii) an authorized representative of a local health department;
106	(iii) an authorized representative of the department;
107	(iv) a registered nurse; or
108	(v) a pharmacist;
109	(b) information regarding each disease against which the student has been immunized
110	by previously contracting the disease; and
111	(c) an exemption form identifying each required vaccination from which the student is
112	exempt, including all required supporting documentation described in Section 53A-11-302.
113	(6) "Legally responsible individual" means:
114	(a) a student's parent;
115	(b) the student's legal guardian;
116	(c) an adult brother or sister of a student who has no legal guardian; or
117	(d) the student, if the student:
118	(i) is an adult; or

119	(ii) is a minor who may consent to treatment under Section 26-10-9.
120	(7) "Licensed health care provider" means a health care provider who is licensed under
121	Title 58, Occupations and Professions, as:
122	(a) a medical doctor;
123	(b) an osteopathic doctor;
124	(c) a physician assistant; or
125	(d) an advanced practice registered nurse.
126	(8) "Local education agency" or "LEA" means:
127	(a) a school district;
128	(b) a charter school; or
129	(c) the Utah Schools for the Deaf and the Blind.
130	(9) "Local health department" means the same as that term is defined in Section
131	<u>26A-1-102.</u>
132	(10) "Required vaccines" means vaccines required by department rule described in
133	Section 53A-11-303.
134	(11) "School" means any public or private:
135	(a) elementary or secondary school;
136	(b) preschool;
137	(c) child care center or program;
138	(d) nursery school; or
139	(e) business that receives compensation for supervising or educating a child.
140	(12) "Student" means an individual who attends a school.
141	(13) "Vaccinating" or "vaccination" means the administration of a vaccine.
142	(14) "Vaccination exemption form" means a form, described in Section 53A-11-302.5,
143	that documents and verifies that a student is exempt from the requirement to receive one or
144	more required vaccines.
145	(15) "Vaccine" means the substance licensed for use by the United States Food and
146	Drug Administration that is injected into or otherwise administered to an individual to
147	immunize the individual against a communicable disease.
148	Section 3. Section 53A-11-302 is repealed and reenacted to read:
149	53A-11-302. Grounds for exemption from required vaccines Renewal.

150	(1) A student is exempt from the requirement to receive a vaccine required under
151	Section 53A-11-303 if the student qualifies for a medical or personal exemption from the
152	vaccination under Subsection (2) or (3).
153	(2) A student qualifies for a medical exemption from a vaccination required under
154	Section 53A-11-303 if the student's legally responsible individual provides to the student's
155	school:
156	(a) a completed vaccination exemption form; and
157	(b) a written notice signed by a licensed health care provider stating that, due to the
158	physical condition of the student, administration of the vaccine would endanger the student's
159	<u>life or health.</u>
160	(3) A student qualifies for a personal exemption from a vaccination required under
161	Section 53A-11-303 if the student's legally responsible individual provides to the student's
162	school a completed vaccination exemption form, stating that the student is exempt from the
163	vaccination because of a personal or religious belief.
164	(4) (a) A vaccination exemption form submitted under this section is valid for as long
165	as the student remains at the school to which the form first is presented.
166	(b) If the student changes schools before the student is old enough to enroll in
167	kindergarten, the vaccination exemption form accepted as valid at the student's previous school
168	is valid until the earlier of the day on which:
169	(i) the student enrolls in kindergarten; or
170	(ii) the student turns six years old.
171	(c) If the student changes schools after the student is old enough to enroll in
172	kindergarten but before the student is eligible to enroll in grade 7, the vaccination exemption
173	form accepted as valid at the student's previous school is valid until the earlier of the day on
174	which:
175	(i) the student enrolls in grade 7; or
176	(ii) the student turns 12 years old.
177	(d) If the student changes schools after the student is old enough to enroll in grade 7,
178	the vaccination exemption form accepted as valid at the student's previous school is valid until
179	the student completes grade 12.
180	(e) Notwithstanding Subsections (4)(b) and (c), a vaccination exemption form obtained

181	through completion of the online education module created in Section 26-7-9 is valid for at
182	<u>least two years.</u>
183	Section 4. Section 53A-11-302.5 is repealed and reenacted to read:
184	53A-11-302.5. Vaccination exemption form.
185	(1) The department shall:
186	(a) develop a vaccination exemption form that includes only the following information:
187	(i) identifying information regarding:
188	(A) the student to whom an exemption applies; and
189	(B) the legally responsible individual who claims the exemption for the student and
190	signs the vaccination exemption form;
191	(ii) an indication regarding the vaccines to which the exemption relates;
192	(iii) a statement that the claimed exemption is for:
193	(A) a medical reason; or
194	(B) a personal or religious belief; and
195	(iv) an explanation of the requirements, in the event of an outbreak of a disease for
196	which a required vaccine exists, for a student who:
197	(A) has not received the required vaccine; and
198	(B) is not otherwise immune from the disease; and
199	(b) provide the vaccination exemption form created in this Subsection (1) to local
200	health departments.
201	(2) (a) Each local health department shall designate one or more individuals from
202	within the local health department as a health official to consult, regarding the requirements of
203	this part, with:
204	(i) parents, upon the request of parents;
205	(ii) school principals and administrators; and
206	(iii) licensed health care providers.
207	(b) A local health department may designate a licensed health care provider as a health
208	official designee to provide the services described in Subsection (2)(a).
209	(3) (a) To receive a vaccination exemption form described in Subsection (1), a legally
210	responsible individual shall complete the online education module described in Section 26-7-9,
211	permitting an individual to:

212	(i) complete any requirements online; and
213	(ii) download and print the vaccine exemption form immediately upon completion of
214	the requirements.
215	(b) A legally responsible individual may decline to take the online education module
216	and obtain a vaccination exemption form from a local health department, if the individual:
217	(i) requests and receives an in-person consultation at a local health department from a
218	health official or a health official designee regarding the requirements of this part; and
219	(ii) pays any fees established under Subsection (4)(b).
220	(4) (a) Neither the department nor any other person may charge a fee for the exemption
221	form offered through the online education module in Subsection (3)(a).
222	(b) A local health department may establish a fee of up to \$25 to cover the costs of
223	providing an in-person consultation.
224	Section 5. Repealer.
225	This bill repeals:
226	Section 53A-11-305, Immunization by local health departments Fees.
227	Section 6. Effective date.
228	This bill takes effect on July 1, 2018.
229	Section 7. Coordinating H.B. 308 with H.B. 309 Superseding substantive and
230	technical amendments.
231	If this H.B. 308 and H.B. 309, Public Health in Schools, both pass and become law, it is
232	the intent of the Legislature that, on July 1, 2018, the amendments to Sections 53A-11-302,
233	53A-11-302.5, and 53A-11-305 in this bill supersede the amendments to Sections 53A-11-302,
234	53A-11-302.5, and 53A-11-305 in H.B. 309 when the Office of Legislative Research and
235	General Counsel prepares the Utah Code database for publication.
