General Description:
This bill amends provisions regarding required information related to a proposed bond.

This bill:
• addresses the order in which a governing body must state the property tax cost of a
bond on a ballot proposition and a voter information pamphlet; and
 makes technical and conforming changes.

Be it enacted by the Legislature of the state of Utah:
Section 1. Section 11-14-202 is amended to read:
11-14-202. Notice of election Contents Publication Mailing.

29	(1) The governing body shall ensure that notice of the election is provided:
30	(a) once per week during three consecutive weeks by publication in a newspaper
31	having general circulation in the local political subdivision in accordance with Section
32	11-14-316, the first publication occurring not less than 21 nor more than 35 days before the
33	election;
34	(b) on a website, if available, in accordance with Section 45-1-101 for the three weeks
35	that immediately precede the election; and
36	(c) in a local political subdivision where there is no newspaper of general circulation,
37	by posting notice of the bond election in at least five public places in the local political
38	subdivision at least 21 days before the election.
39	(2) When the debt service on the bonds [to be issued] the governing body intends to
40	issue will increase the property tax imposed upon the average value of a residence by an
41	amount that is greater than or equal to \$15 per year, the governing body shall prepare and mail
42	either a voter information pamphlet or a notification described in Subsection (6):
43	(a) at least 15 days but not more than 45 days before the bond election;
44	(b) to each household containing a registered voter who is eligible to vote on the
45	bonds; and
46	(c) that includes the information required by Subsections (3) and (4).
47	(3) The governing body shall ensure that the notice and voter information pamphlet
48	required by this section [shall] include in the following order:
49	(a) the date and place of the election;
50	(b) the hours during which the polls will be open; and
51	(c) the title and text of the ballot proposition, including the property tax cost of the
52	bond described in Subsection 11-14-206(2)(a).
53	(4) The governing body shall ensure that the voter information pamphlet required by
54	this section [shall include] includes:
55	(a) the information required by Subsection (3); and

56	(b) an explanation of the property tax impact, if any, of the issuance of the bonds,
57	which may be based on information the governing body determines to be useful, including:
58	(i) expected debt service on the bonds to be issued;

61	(iii) funds other than property taxes available to pay debt service on general obligation
62	bonds;
63	(iv) timing of expenditures of bond proceeds;

65	(vi) any additional information that the governing body determines may be useful to
66	explain the property tax impact of issuance of the bonds.
67	(5) The governing body shall pay the costs associated with the notice required by this
68	section.
69	(6) (a) The governing body may mail a notice printed on a postage prepaid,
70	preaddressed return form that a person may use to request delivery of a voter information
71	pamphlet by mail.
72	(b) The governing body shall ensure that the notice described in Subsection (6)(a)
73	[shall include] includes:
74	(i) the website upon which the voter information pamphlet is available; and
75	(ii) the phone number a voter may call to request delivery of a voter information
76	pamphlet by mail.

83 (a) a ballot title for the bond proposition that includes the name of the local political 84 subdivision issuing the bonds and the word "bond"; and 85 (b) a ballot proposition that meets the requirements of Subsection (2). (2) (a) The governing body shall ensure that the ballot proposition [shall include] 86 87 includes: (i) the maximum principal amount of the bonds; 88 89 (ii) the maximum number of years from the issuance of the bonds to final maturity; 90 (iii) the general purpose for which the bonds are to be issued; and 91 (iv) if issuance of the bonds will require the increase of the property tax imposed upon 92 the average value of a residence by an amount that is greater than or equal to \$15 per year, the 93 following information in substantially the following form and in the following order: 94 "PROPERTY TAX COST OF BONDS: 95 If the bonds are issued as planned, [if applicable: without regard to the taxes currently 96 levied for outstanding bonds that will reduce over time,] an annual property tax to pay debt service on the bonds will be required over a period of years in the estimated amount of 97 **§** [on a] (insert the average value of a residence in the taxing entity rounded to the nearest 98 99 thousand dollars) on a residence and in the estimated amount of \$ on a business property 100 having the same value. 101 [If applicable] If there are other outstanding bonds, an otherwise scheduled tax 102 decrease may not occur if these bonds are issued. 103 The foregoing information is only an estimate and is not a limit on the amount of taxes 104 that the governing body may be required to levy in order to pay debt service on the bonds. The 105 governing body is obligated to levy taxes to the extent provided by law in order to pay the 106 bonds." (b) The governing body may state the purpose of the bonds [may be stated] in general 107 108 terms and need not specify the particular projects for which the governing body intends to issue 109 the bonds [are to be issued] or the specific amount of bond proceeds [to be expended] that the

110 governing body intends to expend for each project. 111 (c) If the governing body intends that the bonds [are to] be payable in part from tax 112 proceeds and in part from the operating revenues of the local political subdivision, or from any combination of tax proceeds and operating revenues, the [bond proposition] governing body 113 114 may indicate those payment sources on the bond proposition, but need not specify how the 115 governing body intends to divide the bonds [are to be divided] between those sources of 116 payment. 117 (d) (i) The governing body shall ensure that the bond proposition [shall be] is followed 118 by the words, "For the issuance of bonds" and "Against the issuance of bonds," with 119 appropriate boxes in which the voter may indicate [his] the voter's choice. 120 (ii) Nothing in Subsection (2)(d)(i) prohibits the addition of descriptive information 121 about the bonds. 122 (3) If a bond proposition is submitted to a vote on the same day as any other election 123 held in the local political subdivision calling the bond election, the governing body or an 124 election officer may combine the bond proposition [may be combined] with the candidate 125 ballot in a manner consistent with Section 20A-6-301, 20A-6-303, or 20A-6-402. 126 (4) The governing body shall ensure that the ballot form [shall comply] complies with 127 the requirements of Title 20A, Chapter 6, Ballot Form. 128 Section 3. 147	notification described in Subsection (6):
148	(a) at least 15 days but not more than 45 days before the bond election;
149	(b) to each household containing a registered voter who is eligible to vote on the
150	bonds; and
151	(c) that includes the information required by Subsections (3) and (4).
152	[(3) The notice and voter information pamphlet required by this section]
153	(3) (a) Except as provided in Subsection (3)(b), the notice described in Subsection (1)
154	shall include, in the following order:
155	[(a)] (i) the date [and place] of the election;
156	[(b)] (ii) the hours during which the polls will be open; [and]
157	(iii) the location of each polling place or the address of a website that lists the location
158	of each polling place; and
159	[(c)] (iv) the title and text of the ballot proposition, including the property tax cost of

170	which may be based on information the governing body determines to be useful, including:
171	(i) expected debt service on the bonds to be issued;
172	(ii) a description of the purpose, remaining principal balance, and maturity date of any
173	outstanding general obligation bonds of the issuer;
174	(iii) funds other than property taxes available to pay debt service on general obligation
175	bonds;
176	(iv) timing of expenditures of bond proceeds;
177	(v) property values; and
178	(vi) any additional information that the governing body determines may be useful to
179	explain the property tax impact of issuance of the bonds.
180	(5) The governing body shall pay the costs associated with the notice required by this
181	section.
182	(6) (a) The governing body may mail a notice printed on a postage prepaid,
183	preaddressed return form that a person may use to request delivery of a voter information
184	pamphlet by mail.
185	(b) The notice described in Subsection (6)(a) shall include:
186	(i) the website upon which the voter information pamphlet is available; and
187	(ii) the phone number a voter may call to request delivery of a voter information
188	pamphlet by mail.
