11	This bill clarifies and makes additions to the designation of aggravated murder victims.
12	Highlighted Provisions:
13	This bill:
14	 adds correctional officers, special function officers, search and rescue personnel,
15	emergency medical personnel, ambulance personnel, and security officers to the list
16	of potential aggravated murder victims; and
17	 clarifies that all peace officers and emergency responders as defined in Utah Code
18	are also to be designated as potential victims of aggravated murder.

Be it enacted by the Legislature of the state of Utah:

28	Section 1. Section 76-5-202 is amended to read:
29	76-5-202. Aggravated murder.
30	(1) Criminal homicide constitutes aggravated murder if the actor intentionally or
31	knowingly causes the death of another under any of the following circumstances:
32	(a) the homicide was committed by a person who is confined in a jail or other
33	correctional institution;
34	(b) the homicide was committed incident to one act, scheme, course of conduct, or
35	criminal episode during which two or more persons were killed, or during which the actor
36	attempted to kill one or more persons in addition to the victim who was killed;
37	(c) the actor knowingly created a great risk of death to a person other than the victim
38	and the actor;
39	(d) the homicide was committed incident to an act, scheme, course of conduct, or
40	criminal episode during which the actor committed or attempted to commit aggravated robbery
41	robbery, rape, rape of a child, object rape, object rape of a child, forcible sodomy, sodomy upon
42	a child, forcible sexual abuse, sexual abuse of a child, aggravated sexual abuse of a child, child
43	abuse as defined in Subsection 76-5-109(2)(a), or aggravated sexual assault, aggravated arson,
44	arson, aggravated burglary, burglary, aggravated kidnapping, or kidnapping, or child
45	kidnapping;
46	(e) the homicide was committed incident to one act, scheme, course of conduct, or
47	criminal episode during which the actor committed the crime of abuse or desecration of a dead
48	human body as defined in Subsection 76-9-704(2)(e);
49	(f) the homicide was committed for the purpose of avoiding or preventing an arrest of
50	the defendant or another by a peace officer acting under color of legal authority or for the
51	purpose of effecting the defendant's or another's escape from lawful custody;
52	(g) the homicide was committed for pecuniary gain;
53	(h) the defendant committed, or engaged or employed another person to commit the
54	homicide pursuant to an agreement or contract for remuneration or the promise of remuneration
55	for commission of the homicide;

90	(l) the victim is or has been a local, state, or federal public official, or a candidate for
91	public office, and the homicide is based on, is caused by, or is related to that official position,
92	act, capacity, or candidacy;
93	(m) the victim is [or has been a peace officer,] on duty in a verified position or the
94	homicide is based on, is caused by, or is related to the victim's position, and the actor knew, or
95	reasonably should have known, that the victim holds or has held the position of:
96	(i) a law enforcement officer, correctional officer, special function officer, or any other
97	peace officer as defined in Title 53, Chapter 13, Peace Officer Classifications;
98	(ii) an executive officer, prosecuting officer, jailer, or prison official[;];

111	structure, or was mailed or delivered;
112	(ii) by means of any weapon of mass destruction as defined in Section 76-10-401; or
113	(iii) to target a law enforcement officer as defined in Section 76-5-210;
114	(o) the homicide was committed during the act of unlawfully assuming control of any
115	aircraft, train, or other public conveyance by use of threats or force with intent to obtain any
116	valuable consideration for the release of the public conveyance or any passenger, crew
117	member, or any other person aboard, or to direct the route or movement of the public
118	conveyance or otherwise exert control over the public conveyance;

(p) the homicide was committed by means of the administration of a poison or of any lethal substance or of any substance administered in a lethal amount, dosage, or quantity;

121	(q) the victim was a person held or otherwise detained as a shield, hostage, or for
122	ransom;
123	(r) the homicide was committed in an especially heinous, atrocious, cruel, or
124	exceptionally depraved manner, any of which must be demonstrated by physical torture, serious
125	physical abuse, or serious bodily injury of the victim before death;
126	(s) the actor dismembers, mutilates, or disfigures the victim's body, whether before or
127	after death, in a manner demonstrating the actor's depravity of mind; or
128	(t) the victim, at the time of the death of the victim:
129	(i) was younger than 14 years of age; and
130	(ii) was not an unborn child.
131	(2) Criminal homicide constitutes aggravated murder if the actor, with reckless
132	indifference to human life, causes the death of another incident to an act, scheme, course of
133	conduct, or criminal episode during which the actor is a major participant in the commission or
134	attempted commission of:
135	(a) child abuse, Subsection 76-5-109(2)(a);
136	(b) child kidnapping, Section 76-5-301.1;
137	(c) rape of a child, Section 76-5-402.1;
138	(d) object rape of a child, Section 76-5-402.3;
139	(e) sodomy on a child, Section 76-5-403.1; or
140	(f) sexual abuse or aggravated sexual abuse of a child, Section 76-5-404.1.
141	(3) (a) If a notice of intent to seek the death penalty has been filed, aggravated murder
142	is a capital felony.
143	(b) If a notice of intent to seek the death penalty has not been filed, aggravated murder
144	is a noncapital first degree felony punishable as provided in Section 76-3-207.7.
145	(c) (i) Within 60 days after arraignment of the defendant, the prosecutor may file notice
146	of intent to seek the death penalty. The notice shall be served on the defendant or defense
147	counsel and filed with the court.
148	(ii) Notice of intent to seek the death penalty may be served and filed more than 60
149	days after the arraignment upon written stipulation of the parties or upon a finding by the court
150	of good cause.
151	(d) Without the consent of the prosecutor, the court may not accept a plea of guilty to

- noncapital first degree felony aggravated murder during the period in which the prosecutor may file a notice of intent to seek the death penalty under Subsection (3)(c)(i).
- (e) If the defendant was younger than 18 years of age at the time the offense was committed, aggravated murder is a noncapital first degree felony punishable as provided in Section 76-3-207.7.
- (4) (a) It is an affirmative defense to a charge of aggravated murder or attempted aggravated murder that the defendant caused the death of another or attempted to cause the death of another under a reasonable belief that the circumstances provided a legal justification or excuse for the conduct although the conduct was not legally justifiable or excusable under the existing circumstances.
- (b) The reasonable belief of the actor under Subsection (4)(a) shall be determined from the viewpoint of a reasonable person under the then existing circumstances.
 - (c) This affirmative defense reduces charges only as follows:
 - (i) aggravated murder to murder; and
 - (ii) attempted aggravated murder to attempted murder.
- (5) (a) Any aggravating circumstance described in Subsection (1) or (2) that constitutes a separate offense does not merge with the crime of aggravated murder.
- (b) A person who is convicted of aggravated murder, based on an aggravating circumstance described in Subsection (1) or (2) that constitutes a separate offense, may also be convicted of, and punished for, the separate offense.
