27	Be it enacted by the Legislature of the state of Utah:
28	Section 1. Section 58-17b-626 is enacted to read:
29	58-17b-626. Direct or indirect remuneration by pharmacy benefits managers
30	Disclosure of customer costs.
31	(1) As used in this section:
32	(a) "Cost share" means the amount paid by an insured customer under the customer's
33	health benefit plan.
34	(b) "Direct or indirect remuneration" means any adjustment in the total compensation:
35	(i) received by a pharmacy from a pharmacy benefits manager or coordinator for the
36	sale of a drug, device, or other product or service; and
37	(ii) that is determined after the sale of the product or service.
38	(c) "Health benefit plan" means the same as that term is defined in Section 31A-1-301.
39	(d) "Pharmacy services administration organization" means an entity that contracts
40	with a pharmacy to assist with third-party payer interactions and administrative services related
41	to third-party payer interactions, including:
42	(i) contracting with a pharmacy benefits manager or coordinator on behalf of the
13	pharmacy; and
14	(ii) managing a pharmacy's claims payments from third-party payers.
4 5	(e) (i) "Reimbursement report" means a report on the adjustment in total compensation
46	for a claim.
47	(ii) "Reimbursement report" does not include a report on adjustments made pursuant to
48	a pharmacy audit or reprocessing.
49	(f) "Sale" means a prescription drug claim covered by a health benefit plan.
50	(2) If a pharmacy benefits manager or coordinator engages in direct or indirect
51	remuneration with a pharmacy, the pharmacy benefits manager or coordinator shall make a
52	reimbursement report available to the pharmacy upon the pharmacy's request.
53	(3) For the reimbursement report described in Subsection (2), the pharmacy benefits
54	manager or coordinator shall:
55	(a) include the adjusted compensation amount related to a claim and the reason for the

57	(b) provide the reimbursement report:
58	(i) in accordance with the contract between the pharmacy and the pharmacy service
59	entity;
60	(ii) in an electronic format that is easily accessible; and
61	(iii) within 90 days after the day on which the pharmacy benefits manager or
62	coordinator receives a report of a sale of a product or service by the pharmacy.
63	(4) A pharmacy services administration organization and a pharmacy benefits manager
64	or coordinator shall, upon a pharmacy's request, provide the pharmacy with:
65	(a) the reasons for any adjustments contained in a reimbursement report; and
66	(b) an explanation of the reasons provided in Subsection (4)(a).
67	(5) (a) A pharmacy benefits manager or coordinator may not prohibit or penalize the
68	disclosure by a pharmacist of:
69	(i) an insured customer's cost share for a covered prescription drug;
70	(ii) the availability of any therapeutically equivalent alternative medications; or
71	(iii) alternative methods of paying for the prescription medication, including paying the
72	cash price, that are less expensive than the cost share of the prescription drug.
73	(b) Penalties that are prohibited under Subsection (5)(a) include increased utilization
74	review, reduced payments, and other financial disincentives.
75	(6) A pharmacy benefits manager or coordinator may not require an insured customer
76	to pay, at the point of sale for a covered prescription drug, more than the lesser of:
77	(a) the applicable cost share of the prescription drug being dispensed; or
78	(b) the retail price of the drug without prescription drug coverage.
