INITIATIVE AND REFERENDUM AMENDMENTS

2019 GENERAL SESSION

STATE OF UTAH

Chief Sponsor: Stephen G. Handy

Senate Sponsor: Daniel McCay

LONG TITLE

General Description:

This bill amends provisions relating to a statewide initiative or referendum.

Highlighted Provisions:

This bill:

- ▶ modifies signature thresholds for statewide initiatives and referenda and bases the thresholds on a percentage of active voters rather than the number of voters in a previous presidential election;
- ▶ clarifies that an initiative that is identical or substantially similar to a previous initiative is barred if signatures for the preceding initiative were submitted within the preceding two years;
- ▶ modifies deadlines relating to statewide initiative petitions;
- ▶ requires county clerks to process signature removal requests for initiatives;
- ▶ removes the provision that legal challenges for initiative signatures declared insufficient may only be filed in the Utah Supreme Court;
- ▶ establishes procedures for the lieutenant governor to follow if an argument relating to an initiative or referendum petition mischaracterizes the position of a state agency; and
- ▶ makes technical and conforming changes.

46 or rejection shall obtain:

114 (1) Persons wishing to circulate an initiative petition shall file an application with the
115 lieutenant governor.

116 (2) The application shall contain:

117 (a) the name and residence address of at least five sponsors of the initiative petition;

118 (b) a statement indicating that each of the sponsors:

- 119 (i) is a resident of Utah; and
120 (ii) has voted in a regular general election in Utah within the last three years;
121 (c) the signature of each of the sponsors, attested to by a notary public;
122 (d) a copy of the proposed law that includes:

155 (1) A Utah voter may sign an initiative petition if the voter is a legal voter.

156 (2) (a) The sponsors shall ensure that the person in whose presence each signature
157 sheet was signed:

158 (i) is at least 18 years old and meets the residency requirements of Section **20A-2-105**;
159 and

160 (ii) verifies each signature sheet by completing the verification printed on the last page
161 of each initiative packet.

162 (b) A person may not sign the verification printed on the last page of the initiative
163 packet if the person signed a signature sheet in the initiative packet.

164 (3) (a) A voter who has signed an initiative petition may have the voter's signature
165 removed from the petition by submitting to the county clerk a statement requesting that the

314 initiative petition that has been declared sufficient by the lieutenant governor may deliver to the
315 lieutenant governor an argument for the adoption of the measure.

316 (B) If two or more sponsors wish to submit arguments for the measure, the lieutenant
317 governor shall designate one of the sponsors to submit the argument for the sponsor's side of
318 the measure.

319 (ii) (A) Any member of the Legislature may request permission to submit an argument
320 against the adoption of the measure.

321 (B) If two or more legislators wish to submit an argument against the measure, the
322 presiding officers of the Senate and House of Representatives shall jointly designate one of the

372 **Preparation of argument of adoption.**

373 (1) (a) Whenever the Legislature submits any measure to the voters or whenever an act
374 of the Legislature is referred to the voters by referendum petition, the presiding officer of the
375 house of origin of the measure shall appoint the sponsor of the measure or act and one member
376 of either house who voted with the majority to pass the act or submit the measure to draft an
377 argument for the adoption of the measure.

378 (b) (i) The argument may not exceed 500 words in length.

379 (ii) If the sponsor of the measure or act desires separate arguments to be written in
380 favor by each person appointed, separate arguments may be written but the combined length of

401 (i) they jointly agree that changes to the argument must be made to correct spelling or

403 (ii) the argument has not yet been submitted for typesetting.

405 the Legislature or by referendum petition has not been filed by a member of the Legislature
406 within the time required by this section:

407 (i) the ~~[Office of the Lieutenant Governor]~~ lieutenant governor shall immediately:

408 (A) send an electronic notice that complies with the requirements of Subsection (4)(b)
409 to each individual in the state for whom the Office of the Lieutenant Governor has an email
410 address; or

411 (B) post a notice that complies with the requirements of Subsection (4)(b) on the home
412 page of the lieutenant governor's website; and

413 (ii) any voter may request the presiding officer of the house in which the measure
414 originated for permission to prepare and file an argument for the side on which no argument
415 has been filed by a member of the Legislature.

416 (b) A notice described in Subsection (4)(a)(i) shall contain:

417 (i) the ballot title for the measure;

418 (ii) instructions on how to submit a request under Subsection (4)(a)(ii); and

419 (iii) the deadline described in Subsection (4)(d).

420 (c) (i) The presiding officer of the house of origin shall grant permission unless two or
421 more voters request permission to submit arguments on the same side of a measure.

422 (ii) If two or more voters request permission to submit arguments on the same side of a
423 measure, the presiding officer shall designate one of the voters to write the argument.

424 (d) Any argument prepared under this Subsection (4) shall be submitted to the
425 lieutenant governor not later than 135 days before the date of the election.

426 (e) The lieutenant governor may not accept a ballot argument submitted under this
427 section unless ~~[it]~~ the ballot argument is accompanied by:

428 (i) the name and address of the ~~[person submitting it, if it]~~ individual submitting the

429 argument, if the argument is submitted by an individual voter; or

430 (ii) the name and address of the organization and the names and addresses of at least
431 two of [~~its~~] the organization's principal officers, if [~~it~~] the argument is submitted on behalf of
432 an organization.

433 (f) Except as provided in Subsection (4)(h), the authors may not amend or change the
434 arguments after they are submitted to the lieutenant governor.

435 (g) Except as provided in Subsection (4)(h), the lieutenant governor may not alter the
436 arguments in any way.

437 (h) The lieutenant governor and the authors of an argument may jointly modify an
438 argument after it is submitted if:

439 (i) they jointly agree that changes to the argument must be made to:

440 (A) correct spelling or grammatical errors; [~~and~~] or

441 (B) properly characterize the position of a state entity, if the argument mischaracterizes
442 the position of a state entity; and

443 (ii) the argument has not yet been submitted for typesetting.

444 (i) If, after the lieutenant governor determines that an argument described in this
445 section mischaracterizes the position of a state entity, the lieutenant governor and the authors of
446 the argument cannot jointly agree on a change to the argument, the lieutenant governor:

447 (i) shall publish the argument with the mischaracterization; and

448 (ii) may, immediately following the argument, publish a brief description of the
449 position of the state entity.
