**LONG TITLE**

**General Description:**

This bill enacts provisions related to exit surveys for licensed public education employees.

**Highlighted Provisions:**

This bill:

- ▶ defines a term;
  - ▶ requires the State Board of Education to make certain rules regarding exit surveys for licensed public education employees;
  - ▶ requires a local education agency to:
    - create an exit survey; and
    - make certain effort to administer an exit survey under certain circumstances;
- and
- ▶ requires reports related to exit surveys.

**Other Special Clauses:**

This bill provides a coordination clause.

35 *Be it enacted by the Legislature of the state of Utah:*

36 Section 1. Section **53G-11-301** is amended to read:

37 **53G-11-301. Definitions.**

38 [Reserved]

39 As used in this part, "educator" means the same as that term is defined in Section  
40 53E-6-102.

41 Section 2. Section **53G-11-304** is enacted to read:

42 **53G-11-304. Educator exit survey -- Rulemaking -- Local education agencies to**  
43 **create and administer exit surveys -- Reporting.**

44 (1) The state board shall make rules that establish:

45 (a) minimum standards for an exit survey described in Subsection (2), including a  
46 model exit survey; and

47 (b) LEA exit survey reporting requirements.

48 (2) An LEA shall, in accordance with the rules described in Subsection (1):

49 (a) for an educator who is leaving employment at the LEA:

50 (i) create an exit survey; and

51 (ii) make the LEA's best effort to administer the exit survey to the educator before the  
52 educator leaves employment at the LEA; and

53 (b) report the results of an administered exit survey to the state board.

54 (3) The state board shall:

55 (a) before taking final action on the rules described in Subsection (1), report the  
56 proposed rules to the Education Interim Committee and consider recommendations from the

57 committee regarding the proposed rules; and

58 (b) on or before November 30, 2020, and as requested by the Education Interim  
59 Committee, report to the committee on the results described in Subsection (2)(b).

60 **Section 3. Coordinating H.B. 130 with S.B. 14 -- Substantive amendment.**

61 If this H.B. 130 and S.B. 14, Education Reporting Requirements, both pass and become  
62 law, it is the intent of the Legislature that the Office of Legislative Research and General  
63 Counsel prepare the Utah Code database for publication by:

64 (1) inserting the following language as a new Subsection 53E-1-201(2)(i):

65 "(i) the reports described in Section [53G-11-304](#) by the state board regarding proposed  
66 rules and results related to educator exit surveys;"; and

67 (2) renumbering remaining subsections accordingly.
