*Be it enacted by the Legislature of the state of Utah:*

#### Section 1. Section 72-4-211 is amended to read:

##### **72-4-211. Mike Dmitrich Highway.**

(1) There is established the Mike Dmitrich Highway composed of the existing Highway 6 from Interstate 15 to Interstate 70.

(2) In addition to other official designations, the Department of Transportation shall designate the portions of the highway identified in Subsection (1) as the Mike Dmitrich Highway on future state highway maps.

(3) As soon as practicable, the Department of Transportation shall install appropriate signs along portion of the highway indicating the designation as the Mike Dmitrich Highway as described in Subsection (1).

Section ~~{1}~~2. Section 72-4-218 is enacted to read:

##### **72-4-218. Grand Army of the Republic Highway.**

(1) There is established the Grand Army of the Republic Highway composed of the existing ~~{Route}~~ Highway 6 within the state.

(2) In addition to other official designations, the Department of Transportation shall designate the highway identified in Subsection (1) as the Grand Army of the Republic Highway on future state highway maps.

#### Section 3. Appropriation.

The following sums of money are appropriated for the fiscal year beginning July 1,

2019, and ending June 30, 2020. These are additions to amounts previously appropriated for fiscal year 2020.
