**LONG TITLE**

**General Description:**

This bill changes the required frequency of driver license and identification card renewal from five years to eight years.

**Highlighted Provisions:**

This bill:

- ▶ changes the initial term and renewal period for a regular class D driver license from five years to eight years;
- ▶ changes the renewal period for a provisional driver license from five years to eight years;
- ▶ changes the renewal period for an identification card from five years to eight years;
- ▶ increases driver license and endorsement and identification card application and renewal fees;
- ▶ adjusts the allowable reportable violations a driver may have on the driver's record to be eligible to renew a license on the eight-year cycle; and
- ▶ makes technical changes.

**Other Special Clauses:**

This bill provides a special effective date.

135 **53-3-205. Application for license or endorsement -- Fee required -- Tests --**  
136 **Expiration dates of licenses and endorsements -- Information required -- Previous**  
137 **licenses surrendered -- Driving record transferred from other states -- Reinstatement --**  
138 **Fee required -- License agreement.**

139 (1) An application for any original license, provisional license, or endorsement shall  
140 be:

- 141 (a) made upon a form furnished by the division; and  
142 (b) accompanied by a nonrefundable fee set under Section 53-3-105.

143 (2) An application and fee for an original provisional class D license or an original  
144 class D license entitle the applicant to:

145 (a) not more than three attempts to pass both the knowledge and the skills tests for a  
146 class D license within six months of the date of the application;

147 (b) a learner permit if needed pending completion of the application and testing  
148 process; and

149 (c) an original class D license and license certificate after all tests are passed and  
150 requirements are completed.

151 (3) An application and fee for a motorcycle or taxicab endorsement entitle the

152 applicant to:

153 (a) not more than three attempts to pass both the knowledge and skills tests within six  
154 months of the date of the application;

155 (b) a motorcycle learner permit after the motorcycle knowledge test is passed; and

156 (c) a motorcycle or taxicab endorsement when all tests are passed.

157 (4) An application for a commercial class A, B, or C license entitles the applicant to:

158 (a) not more than two attempts to pass a knowledge test when accompanied by the fee  
159 provided in Subsection 53-3-105(16);

160 (b) not more than two attempts to pass a skills test when accompanied by a fee in  
161 Subsection 53-3-105(17) within six months of the date of application;

162 (c) both a commercial driver instruction permit and a temporary license permit for the  
163 license class held before the applicant submits the application if needed after the knowledge  
164 test is passed; and

165 (d) an original commercial class A, B, or C license and license certificate when all  
166 applicable tests are passed.

167 (5) An application and fee for a CDL endorsement entitle the applicant to:

168 (a) not more than two attempts to pass a knowledge test and not more than two  
169 attempts to pass a skills test within six months of the date of the application; and

170 (b) a CDL endorsement when all tests are passed.

171 (6) (a) If a CDL applicant does not pass a knowledge test, skills test, or an endorsement  
172 test within the number of attempts provided in Subsection (4) or (5), each test may be taken  
173 two additional times within the six months for the fee provided in Section 53-3-105.

174 (b) (i) Beginning July 1, 2015, an out-of-state resident who holds a valid CDIP issued  
175 by a state or jurisdiction that is compliant with 49 C.F.R. Part 383 may take a skills test  
176 administered by the division if the out-of-state resident pays the fee provided in Subsection  
177 53-3-105(17).

178 (ii) The division shall:

179 (A) electronically transmit skills test results for an out-of-state resident to the licensing  
180 agency in the state or jurisdiction in which the person has obtained a valid CDIP; and

181 (B) provide the out-of-state resident with documentary evidence upon successful  
182 completion of the skills test.

183 (7) (a) (i) Except as provided under Subsections [~~(7)(f)~~] (7)(a)(ii), (f), (g), and (h), an  
184 original class D license expires on the birth date of the applicant in the [~~fifth~~] eighth year  
185 following the year the license certificate was issued.

186 (ii) An original provisional class D license expires on the birth date of the applicant in  
187 the fifth year following the year the license certificate was issued.

188 (b) Except as provided under Subsections (7)(f), (g), and (h), a renewal or an extension  
189 to a license expires on the birth date of the licensee in the [~~fifth~~] eighth year following the  
190 expiration date of the license certificate renewed or extended.

191 (c) Except as provided under Subsections (7)(f) and (g), a duplicate license expires on  
192 the same date as the last license certificate issued.

193 (d) An endorsement to a license expires on the same date as the license certificate  
194 regardless of the date the endorsement was granted.

195 (e) (i) A regular license certificate and any endorsement to the regular license  
196 certificate held by a person described in Subsection (7)(e)(ii), which expires during the time  
197 period the person is stationed outside of the state, is valid until 90 days after the person's orders  
198 have been terminated, the person has been discharged, or the person's assignment has been  
199 changed or terminated, unless:

200 (A) the license is suspended, disqualified, denied, or has been cancelled or revoked by  
201 the division; or

202 (B) the licensee updates the information or photograph on the license certificate.

203 (ii) The provisions in Subsection (7)(e)(i) apply to a person:

204 (A) ordered to active duty and stationed outside of Utah in any of the armed forces of  
205 the United States;

206 (B) who is an immediate family member or dependent of a person described in  
207 Subsection (7)(e)(ii)(A) and is residing outside of Utah;

208 (C) who is a civilian employee of the United States State Department or United States  
209 Department of Defense and is stationed outside of the United States; or

212 (f) (i) Except as provided in Subsection (7)(f)(ii), a limited-term license certificate or a  
213 renewal to a limited-term license certificate expires:

215 the United States or on the date provided under this Subsection (7), whichever is sooner; or

216 (B) on the date of issuance in the first year following the year that the limited-term  
217 license certificate was issued if there is no definite end to the individual's period of authorized

219 (ii) A limited-term license certificate or a renewal to a limited-term license certificate  
220 issued to an approved asylee or a refugee expires on the birth date of the applicant in the fifth  
221 year following the year that the limited-term license certificate was issued.

222 (g) A driving privilege card issued or renewed under Section 53-3-207 expires on the  
223 birth date of the applicant in the first year following the year that the driving privilege card was  
224 issued or renewed.

225 (h) An original license or a renewal to an original license expires on the birth date of  
226 the applicant in the first year following the year that the license was issued if the applicant is  
227 required to register as a sex offender in accordance with Title 77, Chapter 41, Sex and Kidnap  
228 Offender Registry.

229 (8) (a) In addition to the information required by Title 63G, Chapter 4, Administrative  
230 Procedures Act, for requests for agency action, each applicant shall:

231 (i) provide:

232 (A) the applicant's full legal name;

233 (B) the applicant's birth date;

234 (C) the applicant's gender;

235 (D) (I) documentary evidence of the applicant's valid Social Security number;

236 (II) written proof that the applicant is ineligible to receive a Social Security number;

237 (III) the applicant's temporary identification number (ITIN) issued by the Internal

238 Revenue Service for a person who:

239 (Aa) does not qualify for a Social Security number; and

240 (Bb) is applying for a driving privilege card; or

241 (IV) other documentary evidence approved by the division;

242 (E) the applicant's Utah residence address as documented by a form or forms

243 acceptable under rules made by the division under Section 53-3-104, unless the application is

244 for a temporary CDL issued under Subsection 53-3-407(2)(b); and



245 (F) fingerprints and a photograph in accordance with Section 53-3-205.5 if the person  
246 is applying for a driving privilege card;

247 (ii) provide evidence of the applicant's lawful presence in the United States by  
248 providing documentary evidence:

249 (A) that a person is:

250 (I) a United States citizen;

251 (II) a United States national; or

252 (III) a legal permanent resident alien; or

253 (B) of the applicant's:

254 (I) unexpired immigrant or nonimmigrant visa status for admission into the United  
255 States;

256 (II) pending or approved application for asylum in the United States;

257 (III) admission into the United States as a refugee;

258 (IV) pending or approved application for temporary protected status in the United  
259 States;

260 (V) approved deferred action status;

261 (VI) pending application for adjustment of status to legal permanent resident or  
262 conditional resident; or

263 (VII) conditional permanent resident alien status;

264 (iii) provide a description of the applicant;

265 (iv) state whether the applicant has previously been licensed to drive a motor vehicle  
266 and, if so, when and by what state or country;

267 (v) state whether the applicant has ever had any license suspended, cancelled, revoked,  
268 disqualified, or denied in the last 10 years, or whether the applicant has ever had any license  
269 application refused, and if so, the date of and reason for the suspension, cancellation,  
270 revocation, disqualification, denial, or refusal;

271 (vi) state whether the applicant intends to make an anatomical gift under Title 26,  
272 Chapter 28, Revised Uniform Anatomical Gift Act, in compliance with Subsection (15);

273 (vii) state whether the applicant is required to register as a sex offender in accordance  
274 with Title 77, Chapter 41, Sex and Kidnap Offender Registry;

275 (viii) state whether the applicant is a veteran of the United States military, provide

276 verification that the applicant was granted an honorable or general discharge from the United  
277 States Armed Forces, and state whether the applicant does or does not authorize sharing the  
278 information with the Department of Veterans and Military Affairs;

279 (ix) provide all other information the division requires; and

280 (x) sign the application which signature may include an electronic signature as defined  
281 in Section [46-4-102](#).

282 (b) Each applicant shall have a Utah residence address, unless the application is for a  
283 temporary CDL issued under Subsection [53-3-407\(2\)\(b\)](#).

284 (c) Each applicant shall provide evidence of lawful presence in the United States in  
285 accordance with Subsection (8)(a)(ii), unless the application is for a driving privilege card.

286 (d) The division shall maintain on its computerized records an applicant's:

287 (i) (A) Social Security number;

288 (B) temporary identification number (ITIN); or

289 (C) other number assigned by the division if Subsection (8)(a)(i)(D)(IV) applies; and

290 (ii) indication whether the applicant is required to register as a sex offender in  
291 accordance with Title 77, Chapter 41, Sex and Kidnap Offender Registry.

292 (9) The division shall require proof of every applicant's name, birthdate, and birthplace  
293 by at least one of the following means:

294 (a) current license certificate;

295 (b) birth certificate;

296 (c) Selective Service registration; or

297 (d) other proof, including church records, family Bible notations, school records, or  
298 other evidence considered acceptable by the division.

299 (10) (a) Except as provided in Subsection (10)(c), if an applicant receives a license in a  
300 higher class than what the applicant originally was issued:

301 (i) the license application shall be treated as an original application; and

302 (ii) license and endorsement fees shall be assessed under Section [53-3-105](#).

303 (b) An applicant that receives a downgraded license in a lower license class during an  
304 existing license cycle that has not expired:

305 (i) may be issued a duplicate license with a lower license classification for the  
306 remainder of the existing license cycle; and

307 (ii) shall be assessed a duplicate license fee under Subsection 53-3-105(23) if a  
308 duplicate license is issued under Subsection (10)(b)(i).

309 (c) An applicant who has received a downgraded license in a lower license class under  
310 Subsection (10)(b):

311 (i) may, when eligible, receive a duplicate license in the highest class previously issued  
312 during a license cycle that has not expired for the remainder of the existing license cycle; and

313 (ii) shall be assessed a duplicate license fee under Subsection 53-3-105(23) if a  
314 duplicate license is issued under Subsection (10)(c)(i).

315 (11) (a) When an application is received from a person previously licensed in another  
316 state to drive a motor vehicle, the division shall request a copy of the driver's record from the  
317 other state.

318 (b) When received, the driver's record becomes part of the driver's record in this state  
319 with the same effect as though entered originally on the driver's record in this state.

320 (12) An application for reinstatement of a license after the suspension, cancellation,  
321 disqualification, denial, or revocation of a previous license shall be accompanied by the  
322 additional fee or fees specified in Section 53-3-105.

323 (13) A person who has an appointment with the division for testing and fails to keep  
324 the appointment or to cancel at least 48 hours in advance of the appointment shall pay the fee  
325 under Section 53-3-105.

326 (14) A person who applies for an original license or renewal of a license agrees that the  
327 person's license is subject to any suspension or revocation authorized under this title or Title  
328 41, Motor Vehicles.

329 (15) (a) The indication of intent under Subsection (8)(a)(vi) shall be authenticated by  
330 the licensee in accordance with division rule.

331 (b) (i) Notwithstanding Title 63G, Chapter 2, Government Records Access and  
332 Management Act, the division may, upon request, release to an organ procurement  
333 organization, as defined in Section 26-28-102, the names and addresses of all persons who  
334 under Subsection (8)(a)(vi) indicate that they intend to make an anatomical gift.

335 (ii) An organ procurement organization may use released information only to:

336 (A) obtain additional information for an anatomical gift registry; and

337 (B) inform licensees of anatomical gift options, procedures, and benefits.

343 information provided under Subsection (8)(a)(vi) or (viii), for direct or indirect:

- 345 (b) detriment; or
- 346 (c) injury.

347 (18) A person who knowingly fails to provide the information required under  
348 Subsection (8)(a)(vii) is guilty of a class A misdemeanor.

393 **53-3-214. Renewal -- Fees required -- Extension without examination.**

394 (1) (a) The holder of a valid license may renew the holder's license and any  
395 endorsement to the license by applying:

396 (i) at any time within six months before the license expires; or

397 (ii) more than six months prior to the expiration date if the applicant furnishes proof  
398 that the applicant will be absent from the state during the six-month period prior to the  
399 expiration of the license.

400 (b) The application for a renewal of, extension of, or any endorsement to a license shall  
401 be accompanied by a fee under Section 53-3-105.

402 (2) (a) Except as provided under Subsections (2)(b) and (3), upon application for  
403 renewal of a regular license certificate, provisional license, and any endorsement to a regular  
404 license certificate, the division shall reexamine each applicant as if for an original license and  
405 endorsement to the license, if applicable.
