12 **General Description:**

13 This bill modifies provisions of the Legislative Oversight and Sunset Act.

14 **Highlighted Provisions:**

15 This bill:

16 ▶ extends the sunset date of statutory provisions related to the reporting requirements
17 of certain adverse anesthesia events; and

18 ▶ extends the sunset date of statutory provisions related to what constitutes
19 unprofessional conduct when administering anesthesia in an outpatient setting.
