Mr. Speaker,

The Health and Human Services Committee reports a favorable recommendation on **H.B. 344**, STUDENT ASTHMA RELIEF AMENDMENTS, by Representative M. A. Wheatley, with the following amendments:

- 1. Page 3, Line 68 through Page 4, Line 92:
 - 68 potentially fatal anaphylactic reaction.
 - (5) "Health care provider" means an individual who is licensed as:
 - (a) a physician under Title 58, Chapter 67, Utah Medical Practice Act;
 - (b) a physician under Title 58, Chapter 68, Utah Osteopathic Medical

Practice Act;

- (c) an advanced practice registered nurse under Section 58-31b-302; or
- (d) a physician assistant under Title 58, Chapter 70a, Physician Assistant Act.
- 69 $[\frac{(3)}{(5)}]$ $\frac{(6)}{(6)}$ "Qualified adult" means a person who:
- 70 (a) is 18 years of age or older; and
- 71 (b) (i) for purposes of administering an epinephrine auto-injector, has successfully completed the training program established in Section 26-41-104[-]; and
- 73 (ii) for purposes of administering stock albuterol, has successfully completed the
- 74 <u>training program established in Section 26-41-104.1.</u>
- 75 [(4)] $\{\underline{(6)}\}$ "Qualified epinephrine auto-injector entity":
- 76 (a) means a facility or organization that employs, contracts with, or has a similar 77 relationship with a qualified adult who is likely to have contact with another person who
- 78 experience anaphylaxis; and
- 79 (b) includes:
- (i) recreation camps;
- 81 (ii) an education facility, school, or university;

- 82 (iii) a day care facility;
- 83 (iv) youth sports leagues;
- (v) amusement parks;
- (vi) food establishments;
- 86 (vii) places of employment; and

- 88 { (7) } (8) "Qualified stock albuterol entity" means a public or private school that employs,
- 89 contracts with, or has a similar relationship with a qualified adult who is likely to have contact
- with another person who may experience an asthma emergency.
- 91 { (8) } (9) _"Stock albuterol" means a prescription inhaled medication:
- 92 (a) used to treat asthma; and
