General Description:
This bill modifies provisions related to the Talent Ready Utah Center, which is part of
the Governor's Office of Economic Development.

Section 1. Section 63N-12-501 is amended to read:	
CHAPTER 12. PROFESSIONAL AND TECHNICAL WORKFORCE

63N-12-501. Definitions.	
As used in this part:	
(1) "Apprenticeship program" means a program that combines paid on-the-job learning	
with formal classroom instruction to prepare students for careers and that includes:	
(a) structured on-the-job learning for students under the supervision of a skilled	
employee;	
(b) classroom instruction for students related to the on-the-job learning;	
(c) ongoing student assessments using established competency and skills standards;	
<u>and</u>	
(d) the student receiving an industry-recognized credential or degree upon completion	
of the program.	
(2) "Career and technical education region" means an economic service area created in	
Section 35A-2-101.	
[(1)] (3) "Center" means the Talent Ready Utah Center created in Section 63N-12-502.	
[(2)] (4) "High quality professional learning" means the professional learning standards

88	(i) providing students an applied workplace experience using knowledge and skills
89	attained in a program of study that includes an internship, externship, or work experience; and

96	[(1) The center in collaboration with the talent ready board shall partner with private
97	businesses and the State Board of Education to create a pilot program for apprenticeships that
98	begin in grade 11 and grade 12.]
99	[(2) The elements of an apprentice program described in this part may include:]
100	[(a) partnering with private businesses to offer apprentice positions to high school
101	students;]
102	[(b) the center soliciting participation from businesses in various sectors, such as
103	advanced manufacturing, information technology, financial services, business operations, and
104	health care;]
105	[(c) the center in partnership with the State Board of Education soliciting the
106	participation of local education agencies and students;]
107	[(d) students selected for apprentice positions spending part of the students' week
108	learning at school and part of the week learning at a job with a private business;]
109	[(e) the center in partnership with the State Board of Education collaborating with
110	private businesses to ensure that offered apprenticeships provide career competencies and
111	stackable credentials so that the skills apprentices are developing prepare them for the job
112	market;]
113	[(f) the center in partnership with the State Board of Education ensuring that
114	apprenticeship training meets competency-based standards described in Section 53E-4-204;
115	such that the apprentices can graduate from high school in the traditional amount of time;]
116	[(g) the center in partnership with the State Board of Education ensuring that students
117	participating in an apprentice program as described in this section are counted as full-day
118	equivalent pupils of the local education agency the student attends for purposes of state

130	(1) The center in collaboration with the talent ready board may partner with one or
131	more of the following to facilitate and encourage apprenticeship opportunities and work-based
132	learning opportunities for Utah students:
133	(a) the state board;
134	(b) the Utah System of Technical Colleges;
135	(c) the Utah System of Higher Education; and
136	(d) a participating employer in the state.
137	(2) Subject to appropriations from the Legislature and in accordance with the proposal
138	process and other provisions of this section, the talent ready board, with the concurrence of the
139	executive director, may provide funding for approved apprenticeship opportunities and
140	work-based learning opportunities.
141	(3) To receive funding under this section, an entity described in Subsection (1) seeking
142	to partner with the center shall submit a proposal through the center, in a form approved by the
143	center and in accordance with deadlines determined by the center, that contains the following
144	elements:
145	(a) the proposal shall include:
146	(i) a description of the proposed apprenticeship program or work-based learning
147	program that demonstrates the program will be:
148	(A) responsive to the workforce needs of a high demand industry or occupation; and
149	(B) a partnership between at least one participating employer and at least one public
150	high school, technical college, or institution of higher education;
151	(ii) an estimate of:

152	(A) student enrollment in the program;
153	(B) what school credit, credentials, certifications, or other workforce attainments will
154	be provided by the program; and
155	(C) job-placement rates for students who complete the program;
156	(iii) evidence that each participating employer is committed to:
157	(A) participating and contributing to the program; and
158	(B) paying wages to students participating in the program;
159	(iv) a description of any financial contributions or in-kind contributions that will be
160	provided by each participating employer in the program;
161	(v) if the program would require state board approval under the provisions of Section
162	53B-16-102, evidence that the state board has approved the program; and
163	(vi) the amount of funding requested for the program, including justification for the
164	funding; and
165	(b) while not required, a preference may be given to a proposal that includes:
166	(i) a description of a stackable credentialing pathway for participating students that will
167	be created by the program between at least two of the following:
168	(A) a public high school;
169	(B) a technical college; and
170	(C) an institution of higher education; or
171	(ii) the potential for participating students to obtain full-time employment with the
172	participating employer upon completion of the program.
173	(4) The talent ready board shall review and prioritize each proposal received and
174	determine whether the proposal should be funded, using the following criteria:
175	(a) the quality and completeness of the elements of the proposal described in
176	Subsection (3)(a);
177	(b) the quality of the optional elements of the proposal described in Subsection (3)(b);
178	(c) to what extent the proposal would expand the capacity to meet state or regional
179	workforce needs; and
180	(d) other relevant criteria as determined by the talent ready board.
181	(5) A partnership that receives funding under this section:
182	(a) shall use the money to accomplish the proposed apprenticeship program or

183	work-based learning program;
184	(b) may use the money to offset a participating employer's direct operational costs
185	associated with employing students as part of an approved apprenticeship program or
186	work-based learning program;
187	(c) except as provided in Subsection (5)(d), may not use the money for educational
188	administration; and
189	(d) may use the money to support one full-time employee within a career and technical
190	education region if:
191	(i) each participating local education agency, public high school, technical college, and
192	institution of higher education agree on which entity will house the full-time employee;
193	(ii) the full-time employee spends all of the employee's time working exclusively to
194	develop apprentice programs or work-based learning programs; and
195	(iii) the full-time employee is responsible for regular reporting to and receiving training
196	from the director of the center.
197	(6) The center shall be responsible for the administration of apprenticeship programs
198	and work-based learning programs described in this section, including:
199	(a) working with and providing technical assistance to the participating partners that
200	establish apprentice programs and work-based learning programs and that receive funding
201	under the provisions of this section;
202	(b) establishing reporting requirements for participating partners that establish
203	apprentice programs and work-based learning programs and that receive funding under the
204	provisions of this section;
205	(c) providing outreach and marketing to encourage more employers to participate; and
206	(d) annually providing information to GOED regarding the activities, successes, and
207	challenges of the center related to administering apprentice programs and work-based learning
208	programs for inclusion in GOED's annual written report described in Section 63N-1-301,
209	including:
210	(i) specific entities that received funding under this section;
211	(ii) the amount of funding provided to each entity; and
212	(iii) the number of participating students in each apprentice program and work-based
213	learning program.

214	Section 3. Appropriation.
215	The following sums of money are appropriated for the fiscal year beginning July 1,
216	2020, and ending June 30, 2021. These are additions to amounts previously appropriated for
217	fiscal year 2021. Under the terms and conditions of Title 63J, Chapter 1, Budgetary Procedures
218	Act, the Legislature appropriates the following sums of money from the funds or accounts
219	indicated for the use and support of the government of the state of Utah.
220	To Governor's Office of Economic Development - Talent Ready Utah Center
221	From Education Fund \$2,000,000
222	Schedule of Programs:
223	Apprenticeship and Work-Based Learning
224	Opportunities Program \$2,000,000
225	The Legislature intends that:
226	(1) the Talent Ready Utah Center expend appropriations under this item to implement
227	the educational purposes of the apprenticeship and work-based learning opportunities program
228	described in Section 63N-12-507;
229	(2) under Section 63J-1-603, appropriations provided by this item not lapse at the close
230	of fiscal year 2021; and
231	(3) the Governor's Office of Economic Development and the Talent Ready Utah Center
232	may not use money from this appropriation to pay for administrative support provided by the
233	Governor's Office of Economic Development or the Talent Ready Utah Center related to the
234	apprenticeship and work-based learning opportunities program described in Section
235	<u>63N-12-507.</u>
