LONG TITLE

General Description:

This bill amends provisions of the Lobbyist Disclosure and Regulation Act.

Highlighted Provisions:

This bill:

- ▶ defines terms;
- ▶ makes the provisions of the Lobbyist Disclosure and Regulation Act applicable to a person who lobbies a local official or an education official;
- ▶ amends rulemaking authority within the Office of the Lieutenant Governor;
- ▶ defines "foreign agent" and requires a foreign agent to register with the lieutenant governor as a foreign agent;
- ▶ makes changes to the lobbyist license application form;
- ▶ establishes requirements for a foreign agent registration form;
- ▶ requires the name tag of a lobbyist who is a foreign agent to indicate that the lobbyist is a foreign agent;
- ▶ establishes penalties for failure to register as a foreign agent; and
- ▶ makes technical and conforming changes.

45 Section 1. Section **36-11-102** is amended to read:

46 **36-11-102. Definitions.**

47 As used in this chapter:

48 (1) "Aggregate daily expenditures" means:

49 (a) for a single lobbyist, principal, or government officer, the total of all expenditures
50 made within a calendar day by the lobbyist, principal, or government officer for the benefit of
51 an individual public official;

52 (b) for an expenditure made by a member of a lobbyist group, the total of all
53 expenditures made within a calendar day by every member of the lobbyist group for the benefit
54 of an individual public official; or

195 (B) to solicit a campaign contribution that a person is not required to report under a law
196 or ordinance described in Subsection (11)(b)(xi)(A); or

198 (xii) travel to, lodging at, food or beverage served at, and admission to an approved
199 activity;

 368 intentionally assists a lobbyist, principal, or government officer in lobbying.

381 Section 2. Section 36-11-103 is amended to read:

382 **36-11-103. Licensing requirements.**

383 (1) (a) Before engaging in any lobbying, a lobbyist shall obtain a license from the
384 lieutenant governor by completing the form required by this section.

385 (b) The lieutenant governor shall issue licenses to qualified lobbyists.

386 (c) The lieutenant governor shall prepare a lobbyist license application form that
387 includes:

388 (i) a place for the lobbyist's name and business address;

389 (ii) a place for the following information for each principal for whom the lobbyist
390 works or is hired as an independent contractor:

391 (A) the principal's name;

392 (B) the principal's business address;

393 (C) the name of each public official that the principal employs and the nature of the
394 employment with the public official; and

395 (D) the general purposes, interests, and nature of the principal;

396 (iii) a place for the name and address of the person who paid or will pay the lobbyist's
397 registration fee, if the fee is not paid by the lobbyist;

398 (iv) a place for the lobbyist to disclose:

399 (A) any elected or appointed position that the lobbyist holds in state or local

400 government, if any; and

401 (B) the name of each public official that the lobbyist employs and the nature of the
402 employment with the public official, if any;

403 (v) a place for the lobbyist to disclose the types of expenditures for which the lobbyist
404 will be reimbursed; [~~and~~]

405 (vi) a statement that an individual is required to register as a foreign agent under
406 Section 36-11-103.5 before engaging in lobbying on behalf of:

407 (A) a foreign government or an official of a foreign government; or

408 (B) a foreign corporation, or an official of a foreign corporation, that is owned or
409 controlled by a foreign government;

410 (vii) a place for the lobbyist to indicate whether the lobbyist would like to register as a
411 foreign agent; and

412 [~~(vi)~~] (viii) a certification to be signed by the lobbyist that certifies that the information
413 provided in the form is true, accurate, and complete to the best of the lobbyist's knowledge and
414 belief.

415 (2) Each lobbyist who obtains a license under this section shall update the licensure
416 information when the lobbyist accepts employment for lobbying by a new client.

417 (3) (a) Except as provided in Subsection (4), the lieutenant governor shall grant a
418 lobbying license to an applicant who:

419 (i) files an application with the lieutenant governor that contains the information
420 required by this section and, if applicable, Section 36-11-103.5;

421 (ii) completes the training required by Section 36-11-307; and

422 (iii) pays a \$60 filing fee.

423 (b) A license entitles a person to serve as a lobbyist on behalf of one or more principals
424 and expires on December 31 each year.

425 (4) (a) The lieutenant governor may disapprove an application for a lobbying license:

426 (i) if the applicant has been convicted of violating Section 76-8-103, 76-8-107,
427 76-8-108, or 76-8-303 within five years before the date of the lobbying license application;

428 (ii) if the applicant has been convicted of violating Section 76-8-104 or 76-8-304
429 within one year before the date of the lobbying license application;
