	(1) The department shall conduct a study to review scientifically valid research, with a
prio	rity for peer-reviewed studies, regarding:
	(a) the diagnosis, treatment, and care of minors who are transgender; and
	(b) the benefits and side effects of administering a gonadotropin releasing hormone
agen	at which is used to facilitate the minor's gender transition.
	(2) (a) The study described in Subsection (1) shall be conducted by one or more
indiv	viduals who possess a doctoral degree in medicine, pharmacology, or a related field.
	(b) The department may contract to conduct the study described in Subsection (1).
	(3) On or before November 30, 2020, the department shall report to the Health and
Hun	nan Services Interim Committee:
	(a) the results of the study under this section; or
	(b) if the department does not believe that the department will be able to complete the
stud	y under this section on or before November 30, 2020:
	(i) the reason for the delay in completing the study;
	(ii) any steps that the department has taken to prepare the study; and
	(iii) when the department believes that the department will be able to report the results
of th	e study.
