45 (3) The speaker of the House shall select one of the members from the House of  
46 Representatives to act as cochair of the committee.

47 (4) The president of the Senate shall select one of the members from the Senate to act  
48 as cochair of the committee.

49 (5) Compensation and expenses of a member who is a legislator are governed by  
50 Section **36-2-2** and Legislative Joint Rules, Title 5, Legislative Compensation and Expenses.
